Key Finding

Law enforcement may use several statutes to charge violators of COVID-19 Executive Orders.

Details

The following statutes are applicable to offenders who violate any of the current Executive Orders during the COVID-19 pandemic. The charges are all Disorderly Persons offenses.

App. A:9-49(A)	Commit unauthorized act during threat of emergency/safety
App. A:9-49(B)	Commit unauthorized act during threat of emergency/property
App. A:9-49(C)	Hamper/interfere with person authorized by emergency act
App. A:9-49(D)	Drive in prohibited area during state of emergency
App. A:9-49(E)	Enter prohibited area contrary to emergency act
App. A:9-49(F)	Refusal to obey lawful order
App. A:9-49(G)	Refuse to cooperate with person authorized by emergency act
App. A:9-49(H)	Violate governor's orders
App. A:9-50	Aiding and abetting violation

Any New Jersey law enforcement agency using these charges **must first** notify and receive approval from their respective County Prosecutor's Office COVID-19 liaison to the ROIC:
