## NJ LAW ENFORCEMENT DATA & TRENDS

### Total Arrests Statewide (4/15-4/21 vs 4/22-4/28)

- Arrests decreased from 849 to 842 (-0.8%)

### Pandemic-Related Crime Arrests (4/15-4/21 vs 4/22-4/28)

- Burglaries decreased from 90 to 70 (-22.2%)
- Robberies increased from 16 to 18 (+12.5%)
- Shoplifting increased from 31 to 50 (+61.3%)
- Weapons possession decreased from 35 to 34 (-2.9%)

### Shooting Hit Environment (4/22-4/28 this year compared to same time last year)


- Shooting hit victims decreased from 11 to 4 (-64%)
- Shooting homicide victims decreased from 3 to 2 (-33%)
- Total shooting victims decreased from 14 to 6 (-57%)
- Shooting hit incidents decreased from 11 to 4 (-64%)
- Shooting murder incidents decreased from 3 to 2 (-33%)
- Total shooting incidents decreased from 14 to 6 (-57%)

"Threats from groups across the ideological spectrum—from anarchist extremists to white supremacist extremists—have increased public calls for attacks on members of the first responder community. In addition to calls for ideologically motivated attacks on first responders, numerous incidents nationwide involved members of the public purposely attempting to infect officers with COVID-19. During these attacks, individuals cough and/or spit on officers while claiming to be infected with the virus. Many of the individuals committing the attacks do not have the virus but claim to be infected in hopes of escaping arrest or avoiding prosecution...New Jersey Attorney General Gurbir Grewal recently announced increased penalties for individuals who purposely attempt to infect law enforcement and other first responders with COVID-19. These charges include fourth-degree aggravated assault on an officer and second-degree charges of making terroristic threats." - Excerpt from Joint NJROIC-NJOHSP IDR: COVID-19 Threats to First Responders (U//FOUO)

## REPORTED IN OTHER NORTHEAST STATES

- **Bomb threat** received by State Police substation via phone from a male subject.
  - Multiple bombs in multiple buildings that would go off in 16 hours.
  - He would not tell them what buildings or why.
  - Per the station, he also made mention of bombs located in Washington D.C., Chicago, and NYC (Empire State Building).
- Health care workers wearing scrubs and masks counterprotested at rallies.
- Although one state expected an increase due to their expanded unemployment benefit program, that state is seeing a much larger increase than anticipated.
- Healthcare facilities personnel - extortion scam emails.
- Unsolicited offers to establish testing sites which may or may not be legitimate.
- Plans announced for partial re-opening of economies.
- **New York State Contact Tracing**
  - The state will begin its contact tracing efforts to track residents who have contracted the virus and everyone they have been in contact with.
  - According to an official, New York state will need 30 contract tracers for every 100,000 people (that could mean 6,400 to 17,000 tracers across the state).
  - In its contact tracing efforts, the state will use three new smartphone apps to assist with contact tracing.
    - **App #1** will help contact tracers find information and data quickly.
    - **App #2** will help the public provide information to the health departments.
    - **App #3** will allow those in quarantine to access the services.

## STATE PARKS—PARTIAL REOPENING (EXECUTIVE ORDER 133)

- State parks to partially reopen on Saturday, 2 May.
- County parks may also open on 2 May at discretion of county government.
- Parking capped at 50% of capacity.
- STILL CLOSED: Playgrounds, pavilions, visitor centers, restrooms.
- STILL PROHIBITED: Picnics, organized activities, team sports.
- RECOMMENDED: Wear a face covering when social distancing is difficult to maintain.

## IMPLICATIONS FOR LAW ENFORCEMENT

- **Staffing Statewide**
  - **SLEO II/III Temporary Waivers** (document uploaded to LES HSIN sitrooms).
  - **Executive Orders 115/129:** Rehiring retired LEO/extending carry permits.
  - **New Jersey police academies** are temporarily suspended until further notice.
- **New Jersey State Police (NJSP) Field Operations Section** is supporting numerous operations throughout the State.
- **New Jersey Office of the Attorney General (NJOAG)** is currently reviewing requests for clarification to EOs and AOs as well as requests from businesses requesting to be deemed essential. See Daily SEOC sitreps for additional information.
- **New Jersey Department of Corrections (NJDOC)** has temporarily suspended visits in order to mitigate the spread of the COVID-19 virus. This remains in effect.
- **Federal Bureau of Investigation (FBI):** "(U//FOUO) Incarcerated gang members granted early releases due to COVID-19 concerns likely will engage in criminal activity on streets, endangering public safety." - *FBI EIR, released 22 April 2020 (Product is U//FOUO)*
- **Anarchist Extremists:** "... (A March 2020 post was) observed on a **Philadelphia pro-anarchist** site that encouraged followers to utilize the COVID-19 pandemic to further their ideological goals through various criminal activity including: **organizing looting expeditions, organizing rent strikes/open squats, hacking into databases to destroy utility/property records, obstruction of policing/arrests/deportations, and build the capacity to assault/empty prisons.**" - *(U//FOUO) PaCIC Report: Anarchist Extremist Group Encouraging Criminal Activity during COVID-19 Pandemic*
- **Civil Unrest:** Armed protesters in Michigan entered the Statehouse. [BBC News](#)
- **FBI Report:** "(U) Family Members Who Sexually Abuse Children Very Likely Will Capitalize on COVID-19 Social Distancing Restrictions To Exploit Children, Further Endangering Them and Impeding Intervention Efforts" - *FBI EIR, 27 April 2020 (Product is U//LES)*
- **FBI Report:** "(U//FOUO) Outlook: Amid the COVID-19 pandemic, **the FBI anticipates vulnerable individuals aged 65 and older and those with pre-existing medical conditions likely will be more susceptible to mass health care fraud schemes in the next 12 to 24 months.** Patient harm may increase due to provisional drug prescriptions and counterfeit testing kits. ## TRANSPORTATION

### Travel by Rail (Ridership Stats)

- **Amtrak:** Down 90% across country (modified schedule)
- **NJ Transit:** Down 90% system-wide (modified schedule)
- **PANYNJ:** Down 60-70% (modified schedule with 10 min headway between trains)
- **PATCO:** Down 90-92% (modified schedule with 20 min headway between trains)
- **SEPTA:** Operating on Lifeline Schedule. Transit down 91% (with backdoor boarding/no fares) and regional rail down 99%

### Travel by Air

- **Nationwide passenger traffic** remains down an average of -95% from previous yr.
- **COVID at TSA:** To date, a confirmed 505 employees, both screeners and non-screeners, tested positive for COVID-19. 212 employees have recovered, and 5 (2 in Newark) have died as a result of the virus. [TSA Travel Numbers 2019-2020](#)
- **Airlines Note:** American, Delta, Jet Blue, Frontier and United now require face-masks on all passengers from the time they check in until they deplane.

### NYC MTA Disinfection Schedule

- New York City will suspend subway services from 1am to 5am every night beginning 6 May to allow the Metropolitan Transit Authority (MTA) to disinfect trains. The MTA has already been disinfecting subway trains every 72 hours. Buses, shuttle vans, and for-hire vehicles will be provided at no charge to essential workers so they can be transported to their jobs.

### Travel by Water/Ports

- **CBP:** "(U//FOUO) Narcotics: Cocaine and Heroin concealed in shipments of COVID-19 Personal Protective Equipment" - *CBP Intelligence Alert, 27 April 2020*
  - Note: International Incidents. Not yet reported in Sector NY.

## CIVIL UNREST

### COVID-19 Protests For/Against Various Issues:

- Economic (back to work, rent strike)
- Freedom (anti-quarantine, Amendments: 1A/2A/9A/14A)
- Release ICE detainees/inmates
- Lack of PPE (ex. Amazon company worker strikes, medical staff, etc.)
- Anti-LE/Government (ex. Anarchist Extremists)
- Political protests (with 2020 Presidential Election in mind)

## POTENTIAL ISSUES

- **NJ ROIC & NJOHSP Joint IDR:** *Upcoming Dates May Inspire Extremist Activity (U//FOUO)*
- CDC/FEMA/health worker/LE impersonation
- Online gaming complaints/swatting
- Attacks on noncompliant persons concerning stay-at-home orders when infected
- **Civil unrest**
- **Supply chain interruption**
- Drones over FEMA/military hospitals & **threats to medical personnel/infrastructure**
- **Increased alcohol/narcotics addiction relapses & mental health issues, including suicide**

*Analyst Note: Law enforcement should expect many of the problems caused by COVID-19 to ripple long after the state reopens. Financial problems/loss of work/closed businesses and medical concerns (ex. lack of PPE/ventilators) will likely result in continued civil unrest, lawsuits, homelessness, increases in burglary/theft/robbery, extremist recruitment, etc.*

## OFFICE OF DRUG MONITORING & ANALYSIS

- NJ's Drug Monitoring Initiative (DMI) has created a "[New Jersey Resource Guide](#)" to provide partners and the public with a comprehensive directory/list of programs, links, and information to relevant national, state, and county resources for a variety of topics.
- For law enforcement use, these topics include recovery support, social services, mental health, crisis, food bank, emergency shelter, business, home, and first responder resources.
- **DMI recently updated the testing sites information for first responders and added 'Substance Use Disorder & Treatment Services' and 'Grief Support Services' tabs to the Resource Guide.**
- Also reference DMI's *Recommendations for Administering Naloxone During COVID-19* for guidance on how to reduce exposure by wearing proper PPE when responding to potential overdose incidents.

## NJ CYBERSECURITY & COMMUNICATION INTEGRATION CELL (NJCCIC)

- **COVID-19 email/social media-based phishing scams:** Attempt to convince recipients to open links or attachments to direct users to malicious websites or deliver malware, reveal sensitive information, or donate to fraudulent causes.
- **Malicious COVID-19 websites** distributed via emails, malicious advertisements, and social media. Approx. 4,000 coronavirus-themed websites created since January 2020, with at least 5% deemed malicious.
- **The Garden State Network's email content filtering systems detected and blocked 8x as many emails referencing COVID-19 between March-April 2020 compared to January-February 2020.**
- **Threat actors** are likely to take advantage of the rapid increase of telework and attempt to remotely access networks and hide within the increased remote traffic.
- **Threat actors** will likely target individuals and small businesses with payday loan and quick cash scams related to the stimulus package or other relief efforts.

## OPEN SOURCE INTELLIGENCE

- The Cyber Threat Intelligence Unit (CTIU) continues to provide key intelligence reporting of potential mass social distancing violations to its state, county, and municipal partners for heightened caution and situational awareness.
- CTIU continues monitoring the Bergen County Community College and PNC Bank Arts Center FEMA testing sites. As of 0700 hours on 5/1, there appears to be no disruptions or access issues were reported via social media or open source outlets.
- CTIU is monitoring three (3) Field Medical Stations (FMS) sites in Secaucus, Edison, and Atlantic City.
- CTIU is monitoring for threats made against personnel assigned to the tri-state COVID-19 contact tracing partnership.
- CTIU is providing analysis of the Attorney General's website and social media platforms for potential emerging threats as a result of site postings of statewide social distancing violators.
- CTIU, Threat Analysis Unit (TAU), & NJ Office of Homeland Security & Preparedness (NJ OHSP) are partnering on cyber trends for racially-motivated extremism during the COVID-19 pandemic joint intelligence product for dissemination.
- CTIU and TAU co-authored an Intelligence Dissemination Report related to COVID-19 demonstrations, trends, and tactics in NJ for dissemination.
- CTIU will continue to monitor for real-time information and significant threats to the State of New Jersey and will remain in communication with the ROIC-SEOC concerning developments related to current and emerging threats.

- **"The New Jersey European Heritage Association (NJEHA)...**has begun using the coronavirus (COVID-19) as an avenue to progress its rhetoric." Source: [SI Live](#)
- **"A 29-year-old Frenchman who claimed allegiance to the Islamic State group** is facing possible terrorism charges after he rammed his car into police, injuring three officers. The incident occurred Monday (27 April) in the northwestern Paris suburb of Colombes, while police were conducting an ID check. **The driver slammed into police cars and police motorcycles**, sending three officers to the hospital." - **Anarchists** continue to advocate for unlawful civil unrest citing government overreach.

## FIRE INFORMATION—4/28 UPDATE

- Fire personnel survey opened from 7:00AM, Thursday, April 23 until 12:00PM, Monday, April 27
- **427** responses
  - -10.5% decrease from last week's 477 and 60% of departments statewide
- **18,878** fire personnel accounted for via survey
  - 54% of total statewide, which is ~35,000
- **1,362** total fire personnel out via survey
  - **207** fire personnel tested COVID-19 positive
    - -38% decrease from last week
    - 17 are being hospitalized
      - 9-Sussex; 3-Bergen; 2-Passaic; 1-Union; 1-Middlesex; 1-Essex
  - **272** fire personnel are self-quarantining for possible exposure
    - -32.5% decrease from last week
  - **883** fire personnel are out for other reasons
    - -14% decrease from last week
- **17,516** total fire personnel available for duty via survey
  - **33,638** total personnel available based on the approximate statewide number of 35,000
- **157** fire personnel recovered from COVID-19 and returned to work
  - Note: First reporting for this topic
- **822** fire personnel previously quarantined and have since returned to full duty
  - -16% decrease from last week
- **Majority of departments (90%) report they are at 90-100% working capacity**
  - Sussex and Ocean have one department at 50% working capacity or less
  - Byram FD (Sussex) reports 50% personnel availability (4 self-quarantined; 17 out for other reasons)
  - Seaside Park FD (Ocean) reports 30% personnel availability (2 self-quarantined; 2 out for other reasons)
  - Chatham Borough and Holmes Marshal (Piscataway) report 50% capacity or less
- **73%** of departments report that PPE may become critical
- **50%** of departments report cleaning supplies/staff may become critical
- **12%** of departments report that support personnel (EMTs/volunteers) may become critical

## PUBLIC SAFETY ANSWERING POINT (PSAP/911 CALL CENTERS) SURVEY—4/29 UPDATE

### 9-1-1 Call Volume:

- There continues to be reports of general uptick in medical calls, consistent with earlier surveys; however, several PSAPs that previously reported an increase in EMS calls are reporting a downward trend towards 'normal'. Reports indicate a continued rise in domestic violence calls as well as administrative inquiries.
- Two shore resort communities continue to report increased administrative calls related to traveling to secondary homes.
- This reporting period, only one PSAP, Monmouth County, is reporting their 9-1-1 call volume as much higher.
- In 7 counties, 12 PSAPs reported their call volume is somewhat higher than normal, 5 less than last report.
- The remaining 125 PSAPs reported call volume continues to be much lower, somewhat lower, or the same, with many PSAPs continuing to report that while overall call volume is down, EMS and administrative calls are higher.

### Staffing Concerns:

- During this reporting period, there continues to be no reports of serious staffing concerns.
- Of the 138 PSAPs responding, 4 PSAPs reported staffing concerns as bad, down from 5 from last reporting period.
- 53 PSAPs reported staffing either good or very good—10 more than the last report.
- The remaining 81 PSAPs were neutral in their staffing concerns.

### Staff Shortages Related to COVID-19:

- 31 PSAPs reported staff issues to some extent related to COVID-19 - either quarantined or tested positive (essentially the same as the last reporting period).
  - Of the 31 PSAPs reporting COVID-19 related staffing issues, 4 indicated staffing concerns as Bad, a slight decrease from 5 during the last reporting period.
  - 25 PSAPs indicated they have had call takers/dispatchers as confirmed COVID-19 positive.
  - 35 PSAPs indicated they have call takers/dispatchers that are currently under quarantine.
  - 44 PSAPs indicated they've had call takers/dispatchers that have returned from quarantine.
  - This reporting period: No PSAPs reported call taker/dispatcher COVID-19 related deaths.
- The staff of the Office of Emergency Telecommunications Services (OETS) will continue our efforts to increase participation in the surveys going forward. OETS staff continue to engage with each County 9-1-1 Coordinator during the pandemic.*

## SAMPLE COVID-19 CONSPIRACY THEORIES

- **5G cell phone towers:** (Theory A): 5G will be used to create a surveillance state. (Theory B): 5G towers spread the virus.
- **The Chinese government** is responsible for COVID-19. (Theory A): Designed as bioweapon and released on purpose/by accident. (Theory B): Natural outbreak but government allowed it to spread in some capacity. In either theory, the government might've sought to hurt Western economies/purchase cheap stocks.
- **Military bases/facilities** are sometimes singled out in COVID-19 conspiracy theories. See [Port of LA Incident](#).
- **States are confiscating ventilators from rural hospitals** to send to cities, thus sacrificing the lives of citizens living in rural areas in favor of those in/around more populated areas. This idea has been shared on conspiracy theory and non-credible news websites/social media platforms, particularly **Gab** and **4chan**.
- **Militias and anti-government extremists** view the registration of firearms as the first step towards confiscation. They sometimes argue this may be precipitated by a national crisis, evoking of martial law, and involve FEMA "camps". The deployment of the National Guard, pop-up hospitals, and FEMA personnel as well as the misunderstanding of what martial law actually entails may fuel civil unrest.
- **Medical Martial Law aka [Martial Law Lite](#) aka Soft Tyranny** conspiracy theorists argue "hyper-exaggeration and hyper-inflated paranoia and hysteria surrounding the virus" was actually a "conspiratorial plan against the liberties of the American people." **The Jewish community, Democrats, and the New World Order have been named as being behind Medical Martial Law**, with some arguing it is a **Phase 2 false flag attack** of a multi-phase plan for global control (with the Phase 1 false flag operation being the 9/11 attacks). To them, martial law is currently "disguised as executive orders, public safety enforcements, and health mandates," stay-at-home orders are equivalent to mass house arrest, and the **end result is forced vaccinations**, which may be used to alter the DNA of recipients in some way.
  - Note: The conspiracy theory that hospitals are not really overcrowded (#FilmYourHospital movement) is a component of this idea.

## NJOHSP FACTS ON COVID-19 RUMORS AND DISINFORMATION

- A [false infographic](#) circulated on social media appears to contain information from legitimate health organizations, but it intentionally promotes purposely infecting public spaces with COVID-19.
- [False information](#) in the form of audio, texts, and social media postings have stated that the use of ibuprofen can exacerbate COVID-19 symptoms and strengthen the virus.
- No action is needed by most Americans to receive the COVID-19 economic stimulus check. Beware of [scams](#) via mail, phone, email, and social media that ask you to verify your identity or pay a "processing fee."
- A police department in Maine warned of a potential [phishing scam](#) telling text message recipients that someone they recently came in contact with tested positive for COVID-19 or has symptoms.
- [Emails and social media posts](#) describing a self-check exercise to determine if an individual has COVID-19. Self-check assessments are not recommended at this time.
