
Appointments, Publications and Recognition Congratulations to our Faculty and Trainees!



Governor Charles Baker has appointed **Maryann Davis, PhD** to the Task Force to Examine and Study the Treatment and Impact of Individuals Ages 18 to 24 in the Court System and Correctional System. This task force consists of 20 members and its goals are to: 1) Evaluate the advisability, feasibility and impact of changing the age of juvenile court jurisdiction to defendants younger than 21 years of age. 2) Make recommendations for the establishment, implementation and provision to young adults, aged 18 to 24, who have been committed to the department of correction or a county correctional facility with increased and targeted age-appropriate programming and the establishment of young adult correctional units as authorized in section 48B of chapter 127 of the General Laws. 3)

Submit its findings to the clerks of the house of representatives and the senate not later than July 1, 2019.
