### Reading Intervention Options

For the 2018-19 school year, the District is providing i-Ready Reading, in addition to Achieve 3000 and Smarty Ants, as research-based resources to utilize during reading intervention. Principals have the option to utilize one or both reading intervention programs. Teachers have access to Achieve 3000 and Smarty Ants, as well as iReady Reading. Principals will ensure that teachers will receive adequate training. i-Ready and Achieve 3000 Consultants, in addition to the RTI<sup>2</sup> Advisors, are available to provide ongoing support to school staff.

**Changes to a student's intervention can only be determined in a monthly data team meeting and should be updated in the student's RTI plan in EdPlan.** Changes include: increasing frequency of intervention sessions, changing interventions, changing intervention provider, and changing the time of day intervention is being delivered. **To maintain consistency of interventions, students are not to be prescribed both interventions at the same time.**
