Dear Monroe Christian School Families,

The privilege of attending Monroe Christian School for in-person learning during this unprecedented time depends on our collective commitment for each of us to comply with the school's safety measures. Students and families must commit in collaboration with Monroe Christian School to the following health and safety procedures:

- ✓ Following federal, state, and local orders.
- ✓ Stay home if sick, have a temperature of or over 100.4 F, or have been exposed to COVID-19. (Be sure to notify the Monroe Christian School Office if your student/s is/are sick.)
- ✓ Participate in daily temperature checks at school and answer health questionnaires before child/ren exit their cars.
- ✓ Student/s must report feelings of oncoming illness to a teacher and the office as soon as possible.
- ✓ Arrive at school between 8:00-8:30 and proceed directly to classrooms using the outside doors.
- ✓ Wear face coverings.
- ✓ Practice physical distancing.
- ✓ Practice excellent personal hygiene.
- ✓ Carry a refillable water bottle and fill as directed by the teacher. No sharing of food, school supplies, or water bottles.
- ✓ Student/s will do their part to keep the classroom space clean and sanitized throughout the school day as directed by the teacher. (Teachers will always keep in mind the age of their students and their ability to help with certain tasks.)

COVID-19 ASSUMPTION OF RISK, COMMUNITY COMMITMENT, AND RELEASE OF CLAIMS- PLEASE READ CAREFULLY

In consideration for and as a condition of my family's participation in the Monroe Christian School Community for the 2020-21 academic year, I agree as follows:

1. I WILL FOLLOW ALL DIRECTIVES FROM Monroe Christian School staff and volunteers regarding mask use, screening, social distancing, and other procedures intended to reduce the risk of COVID-19 transmission. I will encourage my child to do the same. I understand that these procedures may change.
2. I understand that COVID-19 is a dangerous respiratory illness that can result in permanent disability or death. Although Monroe Christian School has put in place measures to reduce the risk of transmission, I understand that there are no guarantees that my child and my family will not contract or transmit COVID-19 through participation in the Monroe Christian School community. I voluntarily assume all such risks.

3. If my child tests positive for COVID-19 or is recommended to quarantine due to exposure to someone positive for COVID-19, I will notify Monroe Christian School immediately. I will help foster an environment free of shame and judgement so that others are more willing to come forward for the welfare of the Monroe Christian School Community.

I HEREBY RELEASE AND AGREE TO DEFEND AND INDEMNIFY MONROE CHRISTIAN SCHOOL, ITS OFFICERS, DIRECTORS, EMPLOYEES, AGENTS, AND VOLUNTEERS (COLLECTIVELY, RELEASED PARTIES), FROM ANY AND ALL CLAIMS AND LIABILITIES RELATED OR ARISING OUT OF MY CHILD'S OR MY FAMILY'S- EXPOSURE TO COVID-19 IN THE MONROE CHRISTIAN SCHOOL COMMUNITY, EVEN IF THE CLAIMS ARE BASED ON THE NEGLIGENCE OF THE RELEASED PARTIES. THIS RELEASE IS BINDING ON ME AND MY PERSONAL REPRESENTATIVES AND HEIRS. I HAVE CAREFULLY READ THIS DOCUMENT AND UNDERSTAND WHAT IT SAYS.
