Call for Nominations – Submission Deadline October 1st

In accordance with the Bylaws of the Staten Island Multiple Listing Service, Inc. (SIMLS), four (4) two-year director positions on the **2019 SIMLS Board of Directors** must be filled by a vote of the SIMLS Participants on October 18, 2018.

Save-the-Date – Thursday, October 18, 2018 – Election Day

Any MLS Participant who is a member in “good standing” of SIBOR, may submit their name to fill an **Elected Director** position. **Any qualified person submitting their name will be placed on the ballot.** The four (4) persons obtaining the most votes will be appointed Directors for the January 1, 2019 – December 31, 2020 term.

All 2019 directors are required to attend a 2-day Leadership/Strategic Planning Program Monday & Tuesday – NOVEMBER 12 & 13 at a facility in Pennsylvania with overnight accommodations provided

There are **twelve (12) regularly scheduled monthly meetings** of the SIMLS Board of Directors. Any Director who misses **more than three of the twelve regularly scheduled monthly meetings** is automatically removed and their firm may not have a seat on the SIMLS Board of Directors for the remainder of that year and the following year.
