









Laboratory testing for Florida residents and non-Florida residents over the past 2 weeks

Emergency department (ED) and freestanding ED (FSED) chief complaint and admission data for Lee County



Confirmed Countywide COVID-19 Cases vs. Long-term Care Facilities




Confirmed Countywide COVID-19 Cases vs. Long-term Care Facilities

Daily Increase in County-wide Confirmed COVID-19 Cases by Municipality*





Daily Increase in Confirmed COVID-19 Cases by Municipality: Lee County, FL








Cape Coral: COVID-19 Cumulative Totals and Daily Increase


Estero: COVID-19 Cumulative Totals and Daily Increase












Deaths Reported Per Day (Lee County)

Countywide COVID-19 Fatalities vs. Long-term Care Facilities






COVID-19 Cases in Lee Co. by Gender





Countywide Percentage of Total COVID-19 Positive Patients by Age Class




Age Distribution of Cases


Confirmed State-wide COVID-19 Cases FLDOH


Confirmed Cases State-wide With Lee County COVID-19 FLDOH


Daily Increase in Confirmed COVID-19 Cases


Total Statewide Deaths and Daily Increase


