Metro United Way - Farmers Feeding Families Program

The Helps Program distributes items to those in crisis including non-perishable food and home care needs.





Owen County Power Pack Program

The Power Pack Program is a weekly, take-home food program for children in Owen County Schools offered through the Owen County Family Resource Center. Their mission is to meet the needs of children by providing them with nutritious and easy to prepare food to take home on the weekends and school vacations when other resources are not available.

Taylorsville Main Street Association

Taylorsville Main Street, a certified Kentucky Main Street program, is a non-profit organization of volunteers who strive to bring people and businesses to downtown Taylorsville to live, work and play. Their goals are to provide organization, promotion, beautification, and economic restructuring for the city of Taylorsville.
