- A copy of your 2020 tax return
- Photo ID for each adult on tax return
- Original Social Security or ITIN card for each family member
- Income documents for 2021: W-2, 1099Rs, SSA-1099, 1099-MISC, 1099-NEC forms, documentation of cash income
- Bank interest and dividend statements
- 1098T, 1098 Mortgage Statement, Property Tax Statement
- Unemployment income—1099G
- Calculated self-employment income and business expenses up to \$3,500
- Child care provider information and education expenses
- Health forms: Federal 1095-A & CA 3895, and exemption documentation
- IRS Notice 1444
- IRS Notice 6419
- Bank routing and account numbers and bank name for refund direct deposit
