SUBJECT: **Homeless Outreach & Resource Initiatives Update**

The purpose of this Letter to the Commission (LTC) is to inform the City Commission of initiatives being implemented to expand supportive services for our unhoused population while optimizing the use of the Community Court facility.

The Housing and Community Development (HCD) Division's Homeless Initiatives Team is partnering with local service providers to host an event series focused on long-term stability and wellness for our unhoused neighbors and those at risk of homelessness. The overarching goal is to offer viable pathways to independence by providing professional career coaching and employment opportunities, actionable housing and budget strategies, and essential mental health support. Each event is specifically tailored to connect this vulnerable population with vital services and resources needed to transition into stable housing while promoting healthy living.

February 2026 Outreach & Resource Highlights

Photo Identification Day – February 3, 2026

In partnership with the Florida Department of Highway Safety and Motor Vehicles (DMV), City staff hosted a Photo Identification Day at the Community Court facility. The DMV deployed its staff and equipment to issue photo IDs on-site. A total of fifty-six (56) participants attended, and twenty-one (21) received photo identification cards.

Access to photo identification is a critical step for individuals experiencing homelessness, as it enables access to housing, employment, healthcare, and other essential services.

Health and Wellness Day – February 6, 2026

In partnership with various community organizations, City staff hosted a Health and Wellness Day serving seventy-one (71) unhoused participants, along with seventeen (17) donor and partner organizations. Services included blood pressure screening, HIV testing, immunizations, oral health education, and mental health screening. This event supported early intervention, preventative care, and connection to ongoing supportive services.

All seventy-one (71) participants engaged with one or more partner organizations. Notably, fifty-eight percent (58%) of attendees were between fifty (50) and sixty-nine (69) years old.

Program Impact

- Fifty-one (51) participants took part in oral health education
- Forty-eight (48) engaged in substance abuse and detox services
- Forty-eight (48) connected with Broward County Human Services
- Forty-three (43) received blood pressure screenings
- Forty (40) engaged with the South Florida Institute on Aging
- Sixty-nine (69) participants received new or gently used sneakers

Participant feedback was overwhelmingly positive. Respondents expressed interest in repeating the event and recommended adding vision screenings, as well as information on diet and exercise to future offerings.
