**Assumption of Risk.** I understand and acknowledge that certain risks are inherent in field trips and assume responsibility for any such risks associated with participation in the field trip. The field trip risks include, but are not limited to:

Travel and transportation to and from [REDACTED] I understand that injuries or outcomes may arise from student's or other's actions, inaction or negligence, conditions related to travel, or the condition of the field trip location(s). Nonetheless, I acknowledge and expressly assume all risks and dangers associated with all field trip activities (including travel to, from and during the field trip), whether described above, known or unknown, and inherent or otherwise. I take full responsibility for any injury or loss, including death, which the student may suffer, arising in whole or in part from the student's participation in the activities of the field trip.

I understand that private drivers, which may include the parent/guardian of another student participating in the activity, may be used to transport students to and from field trip destinations. The owner of the vehicle must carry bodily injury insurance. The Country School's insurance does not cover damages arising from, or related to, the operation of any private vehicle, failure to follow the directed driving route, or any personal negligence related to this activity. Any liability for damages/harm resulting from a parent/guardian's or other designated driver's operation of a motor vehicle in relation to the above listed activity is hereby waived.

**Voluntary Release of All Claims.** I voluntarily release, discharge, waive and relinquish all claims against the The Country School, its officers, trustees, directors, employees, volunteers, insurers, agents and representatives (collectively "the Released Parties"), arising out of ordinary negligence that are in any way related to or arising from the field trip or transportation to and from the field trip, including but not limited to, claims for bodily injury, personal injury, emotional distress, property damage or wrongful death. This release, discharge, waiver and relinquishment also pertains to any instruction or supervision related to the field trip on the part of the School, its officers, directors, trustees, employees and agents. It is the intent of this Agreement to relieve the Released Parties from negligence to the greatest extent permitted by law.

**Indemnification/Hold Harmless.** Parent(s) or legal guardian(s) of the student may be held liable and responsible for any injury or death to another person or injury to property of another caused by the student. I hereby agree to indemnify (meaning to defend, and to satisfy by payment or reimbursement, including costs and attorneys' fees) and hold harmless the Released Parties with respect to any claims of injury, death or other loss or damage to person or property suffered by any person arising in whole or in part from the conduct of the student while enrolled or participating in the field trip.
