I also understand that fitness activities involve a risk of injury. I hereby agree to knowingly and voluntarily assume and accept any and all risk of injury to my son or daughter (please initial \_\_\_\_\_).

I do hereby further declare that I will notify the supervising teachers and staff of Madonna Learning Center of any condition, impairment, disease, infirmity, or illness that would prevent the student from participation in any of the activities and programs of Madonna Learning Center.
