Project Description: TWG Construction, LLC ("TWG"), an equal opportunity employer, is seeking bidders for "Connection at South Side Apartments" development located at the SW Corner of Sidney and Sarah Streets Pittsburgh, PA. Opportunities are available for one new 6-story total, 5 story wood framed apartment building on top of a concrete podium with amenity space and parking at grade below podium. Total number of apartment units will be 280 consisting of a mix of studio, one-bedroom, and two-bedroom apartments. Site is roughly 1.74 acres, building footprint is roughly 67,280 sft with a total GSF of 297,683 sft.

Project Schedule: The construction schedule will be approximately as follows: **May 2019 – May 2021.** (See Bid Docs for full Schedule)

Minority Participation: As required by the URA, TWG will require the following participation on the overall project: 18% MBE and 7% WBE. Please indicate in your proposal if you have either one or both of these certificates.

General Information:

1. Project is privately funded and has no wage rate requirements. TWG is welcoming both Union and Non-union Bidders
2. Project is not taxable. All bidders **must** include all local, state, and federal sales and use tax as applicable to this project
3. Performance and Payment bond is not required in base bid, but it is requested that all subcontractors provide alternate add if performance and payment bond will be required
4. TWG Construction will be hosting a site visit/general information session at a date to be announced. Date for this event has been scheduled for Tuesday the 16th. Event will start with a jobsite site visit at 1:00 PM. Address for the jobsite is 2984 Sidney Street, Pittsburgh, PA 15203. Note the site is currently an empty lot. After the site visit, the meeting will move over to a conference room at the SpringHill Suites by Marriott Pittsburgh Southside works. Address for the hotel is 2950 South Water Street, Pittsburgh, PA 15203. During the time at the conference room, TWG will open the meeting up to a Q&A session as well as give all subs time to meet with TWG in person. The conference room is reserved from 1 PM to 3 PM
