Introduction

The information contained in Pennsylvania's Annual Drug Evaluation & Classification Program Report is a summary of the accomplishments by the men and women trained and certified as Drug Recognition Experts (DREs) in Pennsylvania. The information was compiled from DRE data reports provided by the Institute for Traffic Safety Management and Research (ITSMR) which captures all Drug Influence Evaluation Reports submitted by all DREs within the Commonwealth.

The Pennsylvania Drug Evaluation & Classification Program (DECP) was established and approved by the International Association of Chiefs of Police (IACP) in November 2004. The first DRE School in Pennsylvania was conducted in February 2005. The first PA DRE Instructor School was conducted in February 2006. The Maryland DRE program played a pivotal role in the early growth and success of the program in Pennsylvania. The statewide program was coordinated by the State Police from 2004 – 2018. In 2018, the coordination duties were reassigned to the Pennsylvania DUI Association due to the growth of the program and the number of agencies and Municipal Officers trained as DREs. All states are currently participating in the program. The DECP operates under the national guidance and direction of the IACP and is supported by the National Highway Traffic Safety Administration (NHTSA). The Pennsylvania DECP is supported by the Pennsylvania Department of Transportation (PennDot), Bureau of Highway Safety Office, the Pennsylvania State Police, the Pennsylvania DUI Association and the Pennsylvania District Attorney's Association.



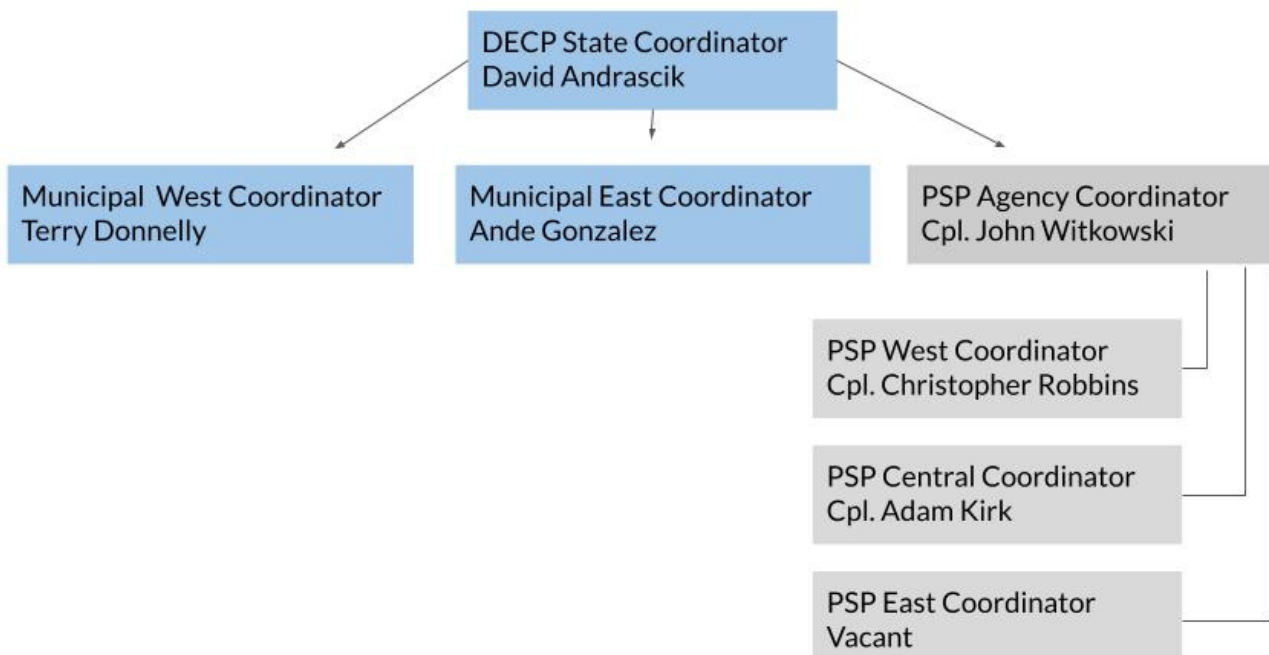

Regional Coordinators were created to assist the State Coordinator with statewide duties. As the number of certified DREs continues to grow, the need for field level managers increases. Currently, the primary duties of the regional coordinators are review and gather recertification materials, as well as to review and approve evaluations submitted by DREs within their region. Each of the Regional Coordinators take on these extra duties in addition to their normal duties and are considered “part time” positions.

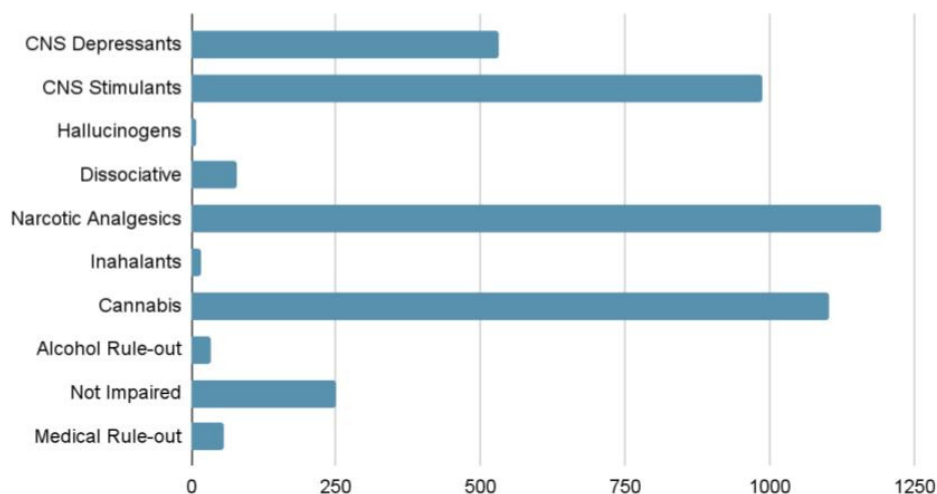

2021 DRE OPINION BY DECP DRUG CATEGORY

The DECP categorizes drugs on the basis of the signs and symptoms of impairment they produce. Seven drug categories are included in the DECP framework, which are Central Nervous System Depressants; Central Nervous System Stimulants; Hallucinogens; Dissociative Anesthetics; Narcotic Analgesics; Inhalants and Cannabis. In addition to these DECP drug categories, DREs are trained to recognize medical conditions which may mimic drug impairment, and also identify subjects who are not under the influence at the time of the evaluation.

The information below details the total number of times each DECP drug category was opined by a DRE, including opinions of alcohol rule-out, not impaired and medical rule-out. This data is related to the enforcement aspect of the DECP.

2021 Training

Welcome to the DRE's who were Certified in 2021!

In 2021, Pennsylvania welcomed 49 new DREs! This is the largest addition in one year in PA. There were 4 DRE Schools conducted. Since the program's inception in PA – there has never been more than 2 schools in a single calendar year. 49 New DREs successfully completed the training, (17 Municipal Officers 32 Troopers) 6 officers received the training but were unsuccessful at completion – this demonstrates the program difficulty and not all that start are able to complete (10.9% failure rate in 2021). The number of certified PA DREs as of December 31, 2021 is 239 (129 Municipal Officers – 110 Troopers).

CERTIFICATION

The Certification Phase of DRE training requires all students to conduct a minimum of twelve drug influence evaluations with subjects believed to be impaired by substances other than alcohol. Completing this phase in a timely manner remains a challenge for every DRE Course Administrator. Philadelphia has been proven to be an excellent location for this portion of the training. In 2021 a total of 10 DRE Classes attended certification in Philadelphia. The four Pennsylvania Schools, as well as Schools from Maryland, New York, Delaware and Minnesota. The success of this location is a direct result of the relationships established with Rock Ministries of Philadelphia and the Center for Forensic Science Research and Education.

Rock Ministries: A Bible, boxing gloves and five boys.... that's how Rock Ministries started. With its goal to reach at-risk inner-city youth with the Gospel of Jesus Christ, the Rock has now grown to serve thousands of kids through sports, arts, music, recreation, mentoring and Bible studies. Through the church Calvary Chapel of Kensington, they also serve the community with outreaches, support for addicts and others in need, a food pantry, and most importantly the consistent teaching of the Word of God. The neighborhood of Kensington is known far and wide as a center of the drug trade with all the crime and violence that it brings. It is among the poorest neighborhoods in America where homelessness and hunger are everyday realities. Rock Ministries have opened their doors for DRE training volunteer subjects. Each class DRE students and Instructors discuss treatment programs and valuable services with the volunteer subjects. Additionally, DRE students provide donated items for those in need. DRE training at the Rock Ministries serves as an excellent community outreach program which helps the community.

The Center for Forensic Science Research and Education: The Center for Forensic Science Research and Education (CFSRE) provides toxicological testing for all certification volunteer subjects. The Director, Dr. Barry Logan has been involved with the DECP Program for decades through his previous work with the Washington State Laboratories as well as his work with National Medical Services (NMS). The Assistant Director, Mandi Mohr serves as a critical role in the collection and testing of all samples. In 2021 CFSRE tested 751 oral fluid samples in which DRE students opined 1,192 drug categories. Many evaluations resulted in the opinion of multiple categories which is the reason of more categories opined than subjects tested. Of the 1,192 categories opined, 1,108 were confirmed by toxicology.

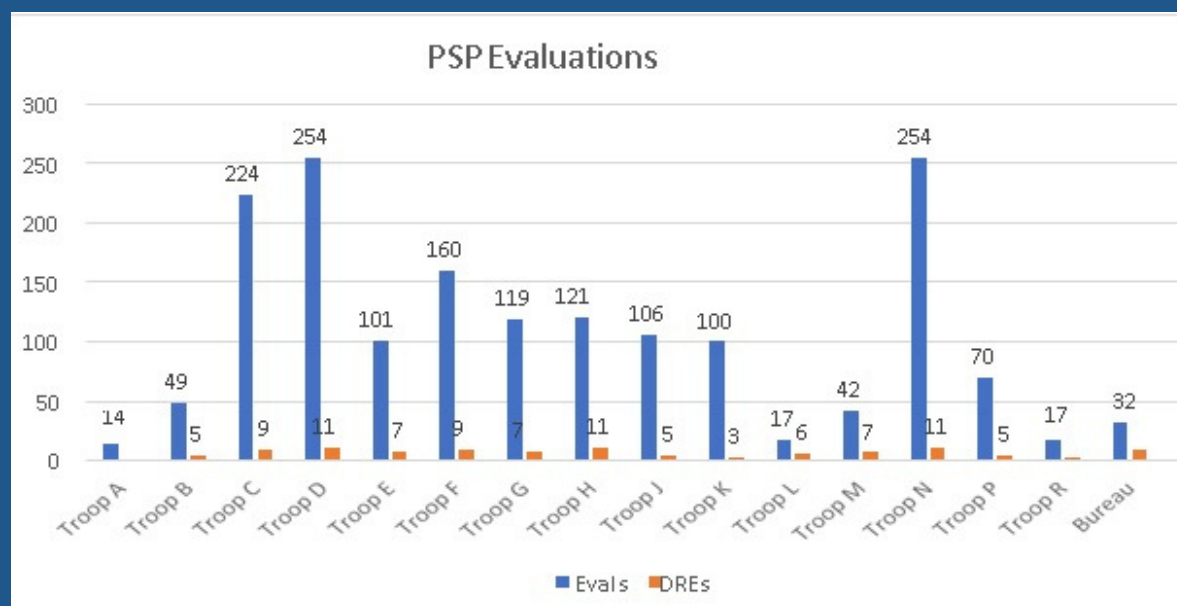

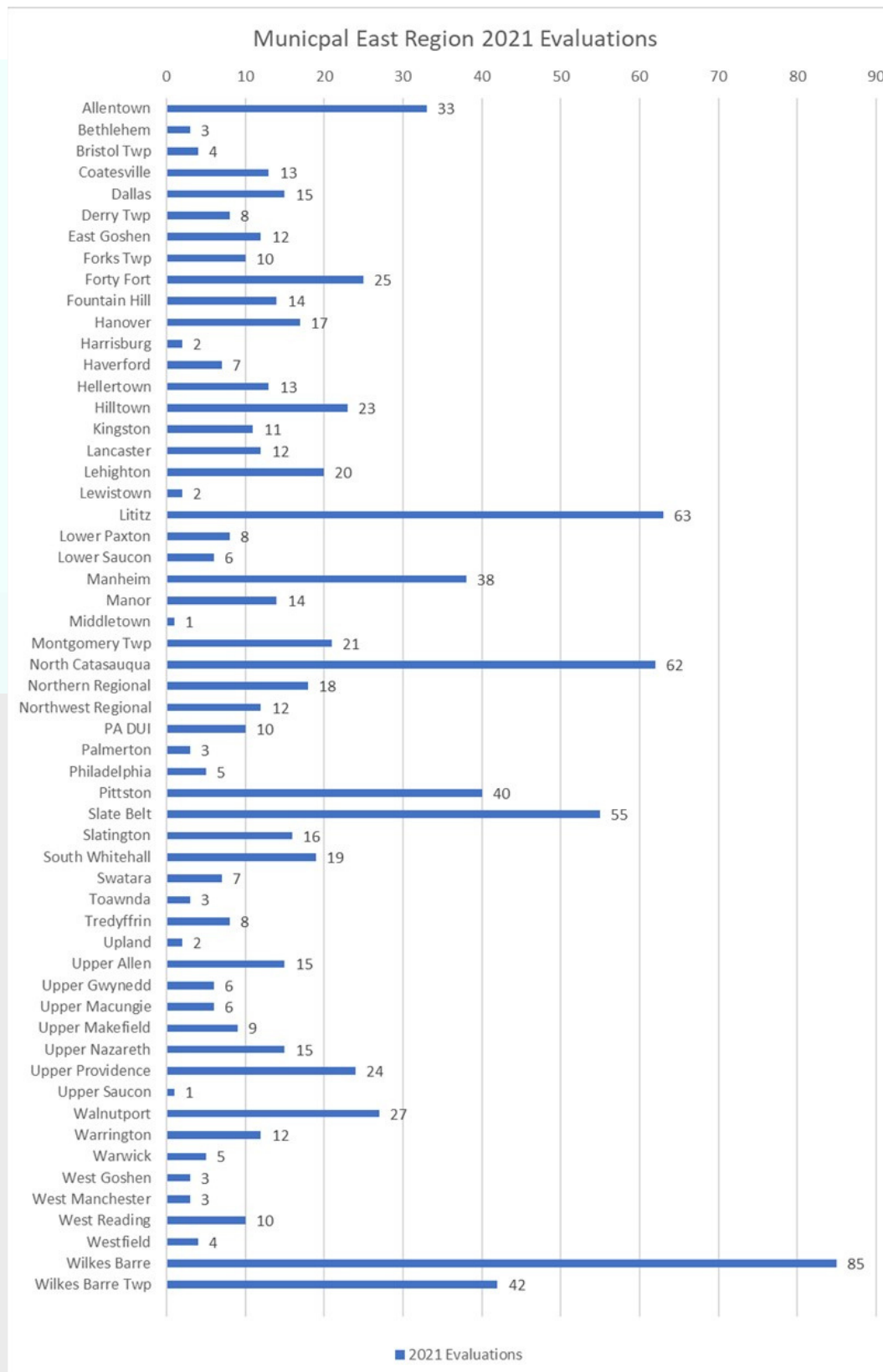

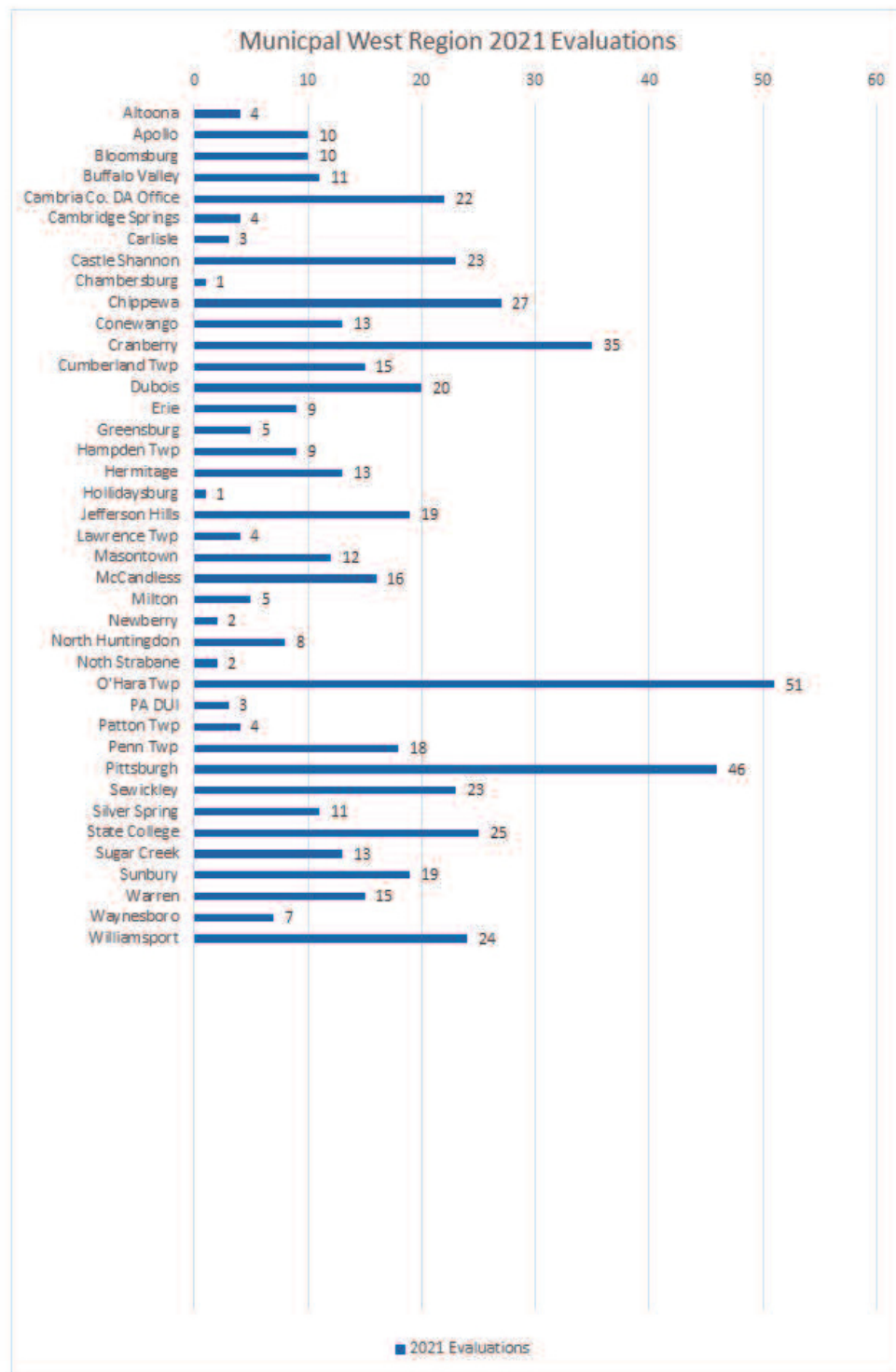
