We will notify applicants on a first come, first served basis once your application is reviewed as space is limited to 10 runners.***

2024 Important Dates & Deadlines

Item	Due Date	Action
Marathon Registration Fee	Time of registration on NYRR website	Registration fee of \$255 for members (or \$315 for non-members) due at the time you register. You, as a runner, are responsible for this fee.
Registration and Cancellation/Drop Deadline	09/10/24	You must register for the race by this date using the e-mail invitation that LPLC sends to you. It is highly recommended to register as soon as possible. <i>Note: If you have registered but cannot race, you must drop by this day to pay the minimum amount of money in drop fees. See Page 4 for details.</i>
TCS New York City Marathon Expo	10/31-11/2/24	Pick up your race number (bib) with timing device, participant shirt, and other race swag. These materials will only be available at the expo. Numbers will only be given to the registered runner . You will need to plan your travel and lodge arrangements to include visiting the expo in NYC.
Deadline to Meet Fundraising Minimum	11/03/24	Your fundraising minimum of \$4,000 must be met by this date. <i>*Runner will be charged difference if they don't meet this deadline.</i>

2023 TCS New York City Marathon	11/03/24	Run like the wind and have fun!
Any Final Funds Raised Must be Mailed to LPLC	11/30/24	All hand-collected money must be postmarked by this date.

2024 TCS New York City Marathon Participant Agreement Terms & Conditions

Fundraising commitment: Beginning on the date of this signed agreement and concluding on **November 3, 2024**, you agree to raise/collect a minimum of \$4,000 and forward 100% of the donations to:

Checks should be forwarded to LPLC within 15 days of receipt. If you are collecting cash, you agree to combine all the monies collected during your fundraiser and write one check for one lump sum made out to **Lee Pesky Learning Center** and mail the check to the address listed above. Per the New York Road Runners Club (NYRR), all online fundraising must take place on LPLC's selected fundraising page.

Registration: You agree to register for the New York City Marathon no later than September 10, 2024, using the e-mail invitation that LPLC sends to you. The Race registration fee of \$255 for NYRR members (or \$315 for non-members), is due at the time you register with NYC Marathon. The Runner is responsible for this non-refundable registration fee. ***Depending on your running goals, we encourage you to review NYRR membership options as it may be worthwhile/cost effective to become a member:*** <https://www.nyrr.org/GetInvolved/Membership>

Cancellation Policy: In the event you choose to cancel this agreement or are unable to run in the NYC Marathon, you may submit a cancellation in writing to the Advancement Department at advancement@lplearningcenter.org. Depending on the date of your cancellation, you hereby authorize LPLC the right to charge your credit card for the following amounts:

If your race cancellation is...

- Prior to September 10th, 2024:
 - o Runner will not be refunded their registration fee to NYRR (\$255/\$315).
 - o Runner will be charged **\$75** by LPLC for the change-fee collected by NYRR in order to enroll a substitute runner from waiting list.
 - o All funds raised to the date of cancellation are forfeited to LPLC and will not be returned.
 - o Runner will be charged the difference in the fundraising minimum (\$4,000) yet to be raised, *unless your substitute raises the difference.*

- After September 10th, 2024:
 - o Runner will not be refunded their registration fee to NYRR (\$255/\$315)
 - o Runner will be charged the cost of the runner team spot that LPLC paid NYRR (\$600).
 - o All funds raised to the date of cancellation are forfeited to LPLC and will not be returned.
 - o **Runner pays difference in the fundraising minimum (\$4,000) yet to be raised.**

Failure to meet Fundraising Minimum Policy: If I complete the marathon but fail to meet the \$4,000 fundraising minimum by 11/03/2024, I authorize LPLC the right to charge **the difference in fundraising minimum (\$4,000) that has yet to be raised** via Haku Fundraising platform.

We appreciate your understanding of the cancellation policies listed above. These policies are in place due to NYRR restrictions on runner registration and adjustments that have been established for security reasons by the race organizers.

Solicitation Policy: This agreement permits you to use Lee Pesky Learning Center’s name for solicitation materials in support of your participation in the 2024 NYC Marathon.

****Prior to printing, publishing, disseminating, or displaying any self-made promotional materials, you must secure approval by Lee Pesky Learning Center for all such materials in which Lee Pesky Learning Center’s name or logo appears.***

You agree to include the following disclaimer on all self-made promotional materials: *“Lee Pesky Learning Center’s name and logo is used with permission, which in no way constitutes an endorsement, express or implied, of any product, service, company, individual, or political position.”*

Travel Policy: You are responsible for arranging travel and lodging for the TCS NYC marathon. You agree to pay all costs associated with your travel to, and lodging in, New York City to participate in the 2024 TCS NYC Marathon (including visiting the Expo), as well as any costs you choose to incur for developing any promotional or marketing materials for the fundraising program. Runners are expected to abide by local, state, and federal COVID-19 safety precautions while traveling (may include proof of negative test or completed vaccination series and/or any pre/post travel quarantine measures implemented by local, state, or federal guidelines).

Release Form and Contribution Agreement: I, the undersigned, agree to the terms and conditions of this agreement to indemnify and hold harmless Lee Pesky Learning Center and NYRR from all cost, expense and liability arising out of my participation in the NYC Marathon to benefit LPLC.

I do hereby waive all claims for damage or loss to me or my property which may be caused by any act or failure to act, by LPLC and NYRR, its officers, agents, volunteers, or employees arising directly or indirectly from my participation in the NYC Marathon; and I hereby assume liability for any loss, damage or other liability from such event.

I hereby give permission to LPLC and their respective designees to take, use, reproduce and publish all photographs and videotapes which may be taken of me immediately before, during, or immediately after the 2024 NYC Marathon without compensation to me. I understand and agree that all such photographs and videotapes will be the sole and complete property of LPLC.
