CANCELTATION POLICY:

In the event that the exhibitor must cancel this agreement, written notice must be received and the following charges will apply:

- Before January 15, 2021 - Total less 20% administration fee.
- From January 15 to February 14, 2021, total less 50% administration fee.
- **AFTER FEBRUARY 14, 2021, NO REFUNDS WILL BE PROVIDED.**

FORCE MAJEURE:

Neither party shall be liable to the other party nor be deemed to have breached or violated this Agreement for failure or delay in performing or enforcing any condition of this Agreement to the extent and during the term, of this default or delay is caused by or results from causes beyond the control of the affected party, including, if not limited to, fires, floods, embargoes, war, acts of war (whether war is declared or not), acts of terrorism, insurgencies, riots, civil unrest, strikes, lockouts or other labor disturbances, acts of force majeure or acts, pandemics, omissions or delays in the action of any government authority or the other part.

In the event of force majeure, a credit note will be provided and funds will be applied to the next event. If the exhibitor wishes to be refunded, any transaction costs incurred will be deducted from the refunded amount. Refunds can take up to 90 days to process.
