# **Leadership & Organizational Growth**

- Served Georgia Justice Project (GJP) since 1986: Volunteer, Staff Attorney, and Executive Director (since 1995).
- Grew GJP's budget from \$200,000 to over \$4 million annually, expanding staff from single digits to over 40 employees.
