

Dear CCAA Members and Friends,

Happy New Year!

As I write this letter, the wonderful year-end holidays are coming to a close, and it is bitter cold and windy outside. Nevertheless, I am really looking forward to 2026 - and I hope you are too!

Last month, December 2025, was a truly exciting and historic month for the arts in Charles County. On December 9, the Charles County Commissioners received the briefing and full report on the proposed new "Charles County Public Arts and Cultural Master Plan" that was developed over the past months by the Department of Recreation, Parks and Tourism (RPT), and it was very well received! This proposed Master Plan builds on the leadership efforts of the Charles County Arts Alliance, when we developed the first-ever strategic plan for the arts in 2008, known as "Arts Vision 2020." Many of you were a part of our own three-year strategic planning effort, and remember it well! At the December 9 Commissioners' public meeting, I was given the opportunity to speak briefly for the record, and I strongly endorsed this proposed Master Plan as the "next logical step" for the arts in Charles County. I spoke on behalf of the CCAA Board of Directors, who were in attendance that day, demonstrating our strong interest and support. The next steps for the new Master Plan will be identified in the weeks and months ahead, and we will keep you posted. In the interim, I invite you to review the RPT presentation and full report and become familiar with it. It will guide our public-private partnership discussions in the future.

This month, we are kicking off our annual CCAA Arts Scholarship Program, which provides a \$2,000 arts scholarship to our Charles County high school students planning to attend a four-year college/university and major in the arts - performing arts, visual arts or literary arts. This is one of our oldest programs in our 38-year history of the CCAA, and we have been so pleased to help launch arts-related careers for many talented young people in our county. Karen McIntyre of our CCAA Board of Directors is chairing our Arts Scholarship Program this year. Please be on the lookout for our CCAA formal announcement coming out later this month.

Next month, we are kicking off our plans for ArtsFest 2026, to be held on Saturday, June 13, 2026, at the Indian Head Village Green and Pavilion. This is another one of our longstanding CCAA programs - our annual free gift to the citizens of Charles County. Please mark your calendars! We promise that this year's event will be even "bigger and better" than last year's very successful event.

# **CCAA at Public Briefing to Charles County Commissioners on Dec 9: Rollout of New "Charles County Public Arts and Cultural Master Plan"**



On December 9, 2025, the Charles County Commissioners were formally briefed on the proposed new Charles County Public Arts and Cultural Master Plan that has been in development over the past year. The Charles County Department of Recreation, Parks and Tourism (RPT) spearheaded this effort, and used a consultant team, Golob Art, to implement this planning project. Beginning in August 2025, the consultant team reached out for direct engagement, input and data gathering with the Charles County arts community (nonprofit organizations, individual artists, arts educators), and the business community, using a variety of avenues:

- Three virtual Zoom sessions
- Three in-person community input meetings (Indian Head, Waldorf, La Plata)
- Numerous one-on-one interviews
- Countywide arts survey

The above outreach efforts, plus additional research on national/state trends and statistics, resulted in the Charles County Public Arts and Cultural Master Plan. The December 9 public rollout briefing to update the County Commissioners was a great success - the Commissioners were very pleased with this effort. The participants at the table for this important briefing were as follows:



Also present in the room for the briefing was Donald Ely, Golob Art consultant team member, and John Hartline, Executive Director of the Tri-County Council of Southern Maryland, which financially supported the Master Plan project via the Rural Maryland Economic Development Fund.

In her remarks, Diane stated that the CCAA strongly endorsed this proposed new Master Plan as the "next logical step" in developing the arts infrastructure in Charles County. She noted that this new Master Plan builds on the earlier first-ever strategic plan for the arts in Charles County, "Arts Vision 2020," which the CCAA had spearheaded over a three-year period and publicly presented in 2008.

It was truly an historic day for the arts in Charles County! We will keep you posted on future actions.

## **Statement by the Charles County Arts Alliance, Inc.**

### **Charles County Commissioners Public Meeting Briefing on Charles County Public Arts and Cultural Master Plan December 9, 2025**

Good afternoon Commissioners.

My name is Diane Rausch. I am the Co-Founder and President of the Charles County Arts Alliance. We were founded and incorporated in 1987 as a 501-c-3 nonprofit organization with one focused mission: to promote all the arts in Charles County - the performing, visual and literary arts. That is, we support music, drama, dance, visual art and literature.

For the past 38 years, we have served as the "designated arts council" of Charles County, and as the "arts umbrella organization" for over 20 other nonprofit arts organizations in our county. We are an "organization of organizations." Our overall reach is in the thousands - our many artists and the arts-loving public in our county.

To date, we have:

- Awarded over \$1,000,000 in our Arts Grants program to support other nonprofit arts organizations in our county, and the Charles County Public Schools.
- Awarded Arts Scholarships each year to our highly talented county high school students planning future careers in the arts.
- Produced and presented our annual free countywide arts festival, ArtsFest, at various locations in our county.
- And most importantly for today's discussion, we led a three-year community-based effort that produced in 2008 the first-ever strategic plan for the arts in Charles County, known as Arts Vision 2020.

And here we are today, 17 years later, discussing the first-ever county government-based strategic plan for the arts, the Charles County Public Arts and Cultural Master Plan.

Today is a momentous, historic occasion for the arts in Charles County!

The Charles County Arts Alliance is pleased to see such a visionary, ambitious, and exciting Master Plan that the Charles County Government has developed for the arts. It will further elevate and develop the arts infrastructure in our community. It is the "next logical step" for all the arts in Charles County, and will take us higher and higher in the future. It will definitely put Charles County on the "arts and culture map" as a destination in the State of Maryland, and will enhance the overall quality of life for our local citizens.

We strongly endorse this visionary Charles County Public Arts and Cultural Master Plan, and extend our congratulations and appreciation to the Charles County Department of Recreation, Parks and Tourism, and their consultant team, who worked so diligently to engage our county citizens in this planning process. For me, the end of the year and holidays inspire reflection and gratitude. These help keep me cozy on the coldest winter days. On December 4th, council members and staff gathered in Bel Air for our final meeting of the year. We heard about the Harford County Cultural Arts Board's great work, toured the Bel Air Arts & Entertainment District, visited the current exhibit at the library branch (our host), and heard from community members about the importance of public funding for the arts. It was my privilege to reflect on and share [our staff's work supporting Maryland's arts sector](#) over the past six months. I look forward to the coming year, working with an incredible team for a truly remarkable, arts-rich state.

Part of my reflection this year is remembering the work and legacy of [Timothy App](#), a pillar of Maryland's visual arts community who [died last month](#). During his time serving as a councilor, Timothy was a fierce advocate for independent artists. Much like [his work](#), his voice in council conversations was restrained but precise and powerful. He could also be unexpected, as when he launched into an impromptu guitar solo to fill the silence during virtual council meetings in the early days of the pandemic. He steered MSAC policy and practices toward inclusiveness while maintaining rigor, and that work will live on in MSAC's programs, a legacy benefiting all Maryland artists.

Happy holidays, and I hope you take some time for your own reflection. There's nothing cozier.

## Maryland Arts Day 2026: Advocacy for the Arts in Annapolis

CCAA members are invited to participate in **Maryland Arts Day 2026**, hosted by the Maryland Citizens for the Arts (MCA). This annual statewide advocacy event brings together artists, arts leaders, and supporters to speak directly with Maryland lawmakers about the importance of public support for the arts.

**Maryland Arts Day will take place in person on Thursday, February 12, 2026**, beginning with a morning program at **St. John's College in Annapolis**, followed by scheduled visits with state legislators at the Maryland State House. Participants will have the opportunity to represent their local arts communities and help ensure the arts remain a funding and policy priority across the state.

The purpose of Maryland Arts Day is simple: to advocate for continued and increased investment in the arts, culture, and creative community in Maryland. By sharing real stories and community impact, attendees help lawmakers understand why the arts matter to education, community development, tourism, and quality of life.

Space is limited, and early registration is encouraged. Participants are also invited to nominate an individual for the **Sue Hess Arts Advocate of the Year Award**, which is presented during the event.

CCAA encourages members to attend and lend their voices to this important statewide effort. Maryland Arts Day is a meaningful opportunity to connect with elected officials, stand alongside arts advocates from across the state, and champion the future of the arts in Maryland.

### Mid Atlantic Arts Foundation New Strategic Plan: "Imagine Next!"




