## SMALL WORKS SHOW

*Seven 3-Day Weekends to Sell Your Art!*



*This year, for the first time, Mattawoman Creek Art Center is adding a Small Works Show to its Holiday Salon. The idea is to allow artists to enter just a few small pieces of original artwork to be priced with gift-giving in mind. If you are an artist and are not up to supplying the quantity of items needed for a Holiday Salon booth, we hope you will consider this option for displaying and selling your artwork this Holiday Season!*

### **GUIDELINES:**

- Exhibitors need not be present during all show times; docents\* will handle sales for you!
- \* Exhibitors must agree to docent at least once during the exhibit.
- Opening Reception is Sunday, November 5, 1:00-4:00 p.m. Artists are encouraged to attend.
- The Holiday Tea is Sunday, November 19, 1:00-4:00 p.m. Artists are encouraged to attend.
- The artwork entered in the **Small Works Show**:
  - Must be original artwork.
  - May be 2-dimensional or 3-dimensional.
  - Must not exceed 12" in any dimension (not including frame).
  - Must be clearly labeled with the title, medium, price, and name and phone number of the artist.
  - Must be ready to hang on the wall or displayed on a pedestal (to be provided by MCAC). MCAC hanging standards apply, with the exception that saw-tooth hangers may be used.
  - The price of each piece of artwork must be \$100 or less.
- Artwork may be taken by the purchaser immediately upon sale. The artist may replace artwork as sold, but must update their inventory sheet at that time.
- Contrary to usual rules, artwork shown at MCAC within the past year may be included in this show.
- Art may not be switched between the gift shop and gallery for the duration of the Holiday Salon show.
- All pieces must be for sale. MCAC retains 25% commission on sales.

**Entry Fee:** \$10 for 4 pieces of artwork for MCAC members and \$15 for non-members.

**Registration:** Artwork may be registered when delivered. See Artwork Delivery Dates below. If you would care to pre-register to guarantee your place in the Small Work Show, use the form below. Space is limited.

**Artwork Delivery Date:** Small Work artwork must be hand-delivered and outstanding fees paid on one of the following dates: **Sat., Oct. 28 from 11:00 – 1:00 or Sun. Oct. 29 from 2:00 – 4:00.**

**Retrieval Date:** Artwork may not be removed before 4:00 p.m. on Sunday December 17, but must be removed by Tuesday, December 19. Select a time when you deliver and register your artwork.

**\*LIABILITY:** MCAC will not be responsible for any loss or damage. MCAC will not be responsible for artwork left after retrieval dates. After 30 days, abandoned items will become the property of MCAC.
