### ELIGIBILITY

### PHOTO CRITERIA

- The photo must incorporate the concept "Community Bank of \_\_\_\_\_"
- Only landscape-oriented photos will be considered. Photos must be able to fit the 8 1/2" x 11" calendar format. Photos that are selected may be cropped for that format.
- The photos submitted must be the original work of the person submitting the photo.
- The photo must meet the minimum required 300 DPI (dots per inch).
- All photos submitted should be high resolution.

### ENTRANT MUST SUBMIT

- A photo release form with each photo. If people's\* faces are photographed, please make sure "person photographed" signs your form too.
