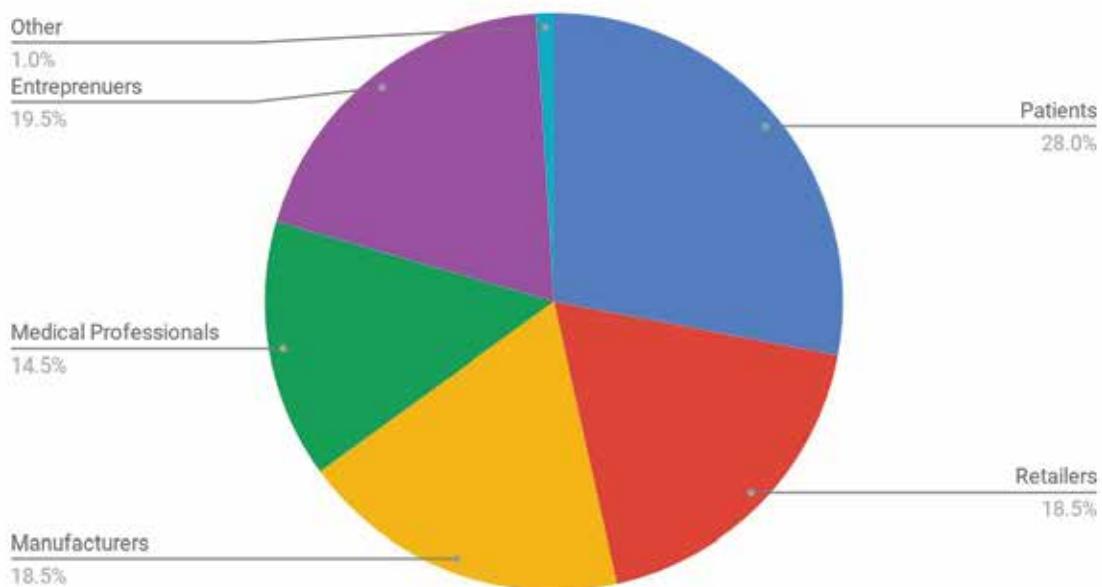

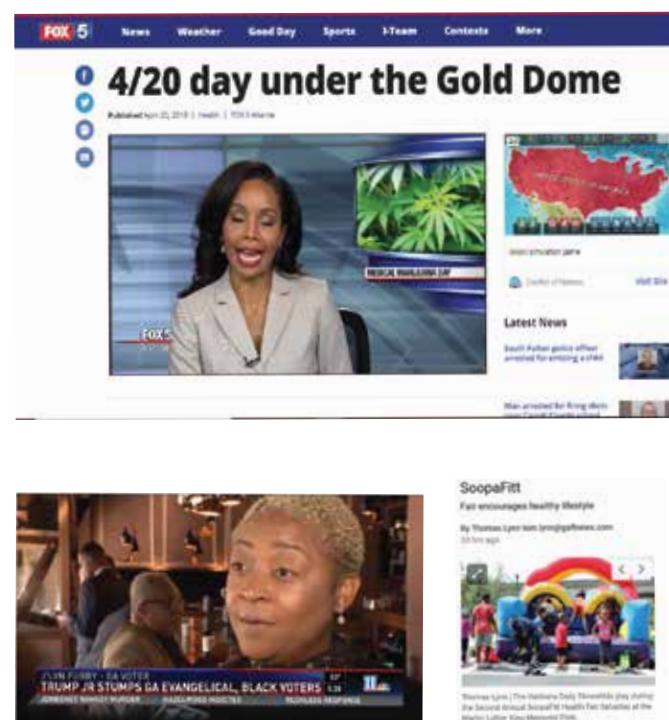

Throughout my life, I've always been proud to call Gwinnett County home. I am a progressive raised by progressives. Thus, I've spent a lifetime embracing, and working for, change. My parents were politically active in the anti-Vietnam war effort in the late 1960's and into the early 70's. When I graduated from Shiloh High School, I pursued my college career at the American University. While in college, I started my own work in politics. This included volunteering on the 1988 Al Gore for President campaign and volunteering at the 1988 Democratic Convention in Atlanta. I received a bachelor's degree in broadcast journalism and international studies and went on to receive my J.D. from Georgia State University.

Most recently, I served in the Georgia State Legislature for the last 16 years. My biggest legislative accomplishment that affects people locally is the bill I helped pass to create Community Improvement Districts (CID's) in Gwinnett County. I served on the Gwinnett Village CID for 10 years (now the Gateway 85 CID) and I was the first, and founding, president. This work on CID's gave me experience working on local government issues and local planning. Much of this experience focused on the transportation planning for mass transit that, along with the work of countless others, has ultimately grown into the Connect Gwinnett plan that is part of the 2019 Transit Referendum.

Throughout my career, I have continued to stand up for progressive causes. As a constant advocate for LGBTQ+ rights, I continuously opposed anti-LGBTQ+ legislation. In 2003 and 2004, I led the fight against the state constitutional amendment that would ban same-sex marriage. I also co-sponsored legislation to address hate crimes, bullying and voting rights.

As a legislator, I was the first in Georgia to propose a referendum that would allow Georgians to vote on the legalization of retail marijuana sales. Additionally, I was the first to propose full-spectrum medical marijuana legislation. Each year, I worked with the state legislature to expand Georgia's medicinal cannabis CBD oil laws.

I am also proud to have been a co-sponsor of the Georgia Entertainment Industry Investment Act – the bill that created the tax credits that have brought so much movie and television industry business to Georgia. Gwinnett County has specifically benefited from Eagle Rock Studios.

Over the years, I have had the opportunity to volunteer with, and serve on the boards of, AID Gwinnett, Gwinnett Sierra Club, Gwinnett Habitat for Humanity, and Norcross Cooperative Ministry. Currently, I am a member of the Sierra Club and the Peachtree Corners Rotary Club.

I continue to live and work in Gwinnett and want to ensure that we build a bridge to a bolder and brighter future for our county and all those in it. My values are to ensure that my fellow citizens are safe, treated with respect, have equal opportunity, and are free from discrimination of any kind. I hope you join me in our campaign for Gwinnett's future.

Ted Metz is a US Navy Veteran and activist for laissez-faire government, especially in the Cannabis space. Since 2014 he has attended committee hearings to show support, testify, and lend advice to Georgia Legislators regarding medical cannabis, criminal justice reform, and hemp. Ted has testified around the state to advance the decimalization of personal possession and campaigned statewide to get hemp back into our economy.

“Humanity will be transformed when cannabis is returned to our food chain, as will global economies with industrial hemp,” Metz says. He backs his confidence in that statement citing highlights of his academic achievements - Biology and Organic Chemistry at UGA, Nursing at Perimeter College, Business Administration at GSU. Metz said, “As a serial entrepreneur, I am excited about the possibilities that follow the resurgence of cannabis.”

Metz stays active in several organizations focused on restoring or maintaining our natural rights and holding elected officials accountable to their oath of office. Metz speaks to groups and organizations at every opportunity to share his knowledge about hemp, and/or the health benefits of cannabis and his cancer experience with it. In 2018 he ran for Governor of Georgia as the Libertarian candidate and will continue to run with the goal of changing the dialog.

Tianna Smith, MBA is a New Jersey native on a mission to advocate, educate and empower women worldwide. In addition to being a prominent industry advocate by chartering West Georgia NORML Women's Alliance, she is also the Visionary behind the Hemp House Foundation Inc. a nonprofit organization that fosters entrepreneurship and wellness in the cannabis space.

The vision behind the Hemp House Foundation is to unite the budding brand with appropriate resources and funding to establish a sustainable business in the industry as well as providing a wellness experience that caters to diverse, disadvantaged and overlooked conditions that impact mind, body and soul.

After her diagnosis with a rare brain disorder called Chiari Malformation Type I, she believes the cannabis movement should be a wake-up call to the healthcare and political system as it has been proven to assist in treating many symptoms of chronic conditions.

As the current Market Leader for Women Grow Atlanta, she focuses on removing the stigma around the plant and pushing for diversity and fairness in the cannabis industry. Tianna enjoys spending time with her husband, three children and fur baby "Chiari". She loves traveling, good food and intimate gatherings with great vibes.

In 2013, Corey left the City of Clarkston Police Department in order to pursue Cannabis as an option for her daughter, Victoria Elizabeth who suffered from seizures, daily. As far back as those years when she was growing up in DeKalb County, Georgia – whose streets she would later patrol as a police officer – Corey Lowe has been very much about helping people.

Her background is an amazing eclectic mix of service, from coordinating multi-million-dollar trade shows to organizing small-budget community- safety meetings, from an extensive law-enforcement career to lobbying the Georgia legislature to ensure patients in need of medical marijuana might find relief. Born in Atlanta, Ga on Friday October 13, Corey was deep into her career within the trade show industry, where she took pride in maximizing the trade-show experience for her clients, when her life changed forever on Sept. 11, 2001.

Corey got all the 9/11 news from busy doctors and nurses in a downtown Atlanta hospital, where she was preparing to give birth to her daughter Victoria Elizabeth. New motherhood changes anyone's life, but that's especially so when – within months – the joy of the new arrival is tempered with the diagnosis of epilepsy, Infantile spasms. After trying a cocktail mix of different seizure drugs, obtaining a seizure alert dog, taking Victoria to Detroit and traveling to California, seeking answers on how to control her daughter's seizures. She finally made cannabis as an option. She left policing in 2013 in order to become an activist on behalf of children like Victoria.

In, 2014 when Georgia HB885 died on March 20th. Corey was able to take Victoria to Colorado with the help of the Journey of Hope fund and Senator Butch Miller. They left, Friday, June 13th and then on June 18th, 2014, Victoria had her first dose of cannabis oil. A few months later, she suddenly spoke for the first time. But they had to return home to Georgia, where cannabis oil was not legal. Victoria's journey has been documented on Paws for a princess, which you can find on Facebook. There's a video showing a seizure stopped in its tracks using a rescue cannabis spray!

She joined other parents in co-founding a group now known as Georgia's Hope to work toward the day that this medical option can be accessible to make a positive difference in the lives of all who need it. Corey gives her Grandmother Betty a lot of credit for her compassionate nature. Years before Corey was born, when her mother was just a little girl in the 1950's, her grandmother was one of the few adults around who set the right example for her children in openly condemning segregation – at a time when it wasn't necessarily safe to do so. That doesn't mean she's about to slow down.

She is a contributing writer for Canna Health magazine and was most recently accepted as a speaker for the National organization known as L.E.A.P- Law Enforcement Action Partnership. Most recently Corey has been invited to England so that she could share her daughter's journey with cannabis oil, she's looking forward to continuing to share her story on 4/20/2020!

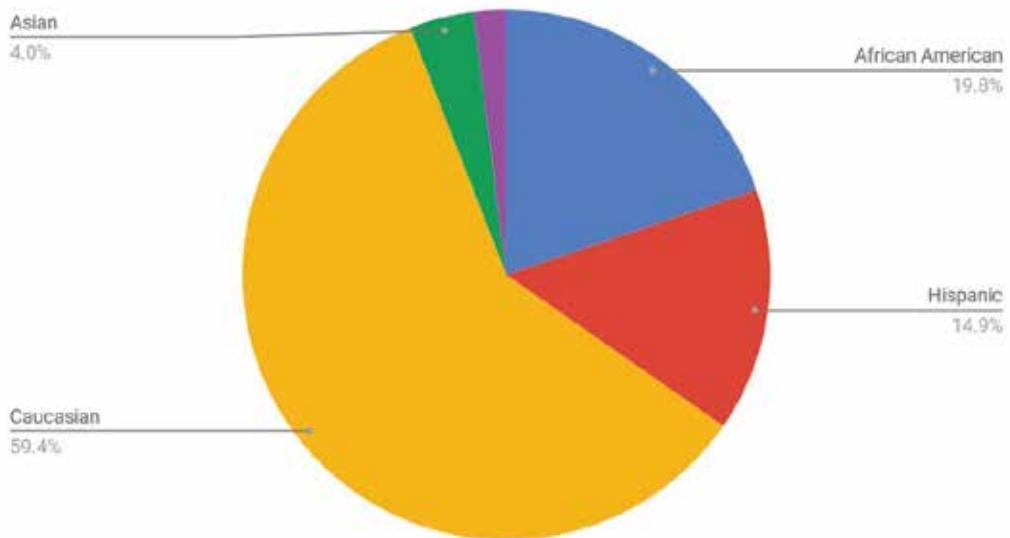

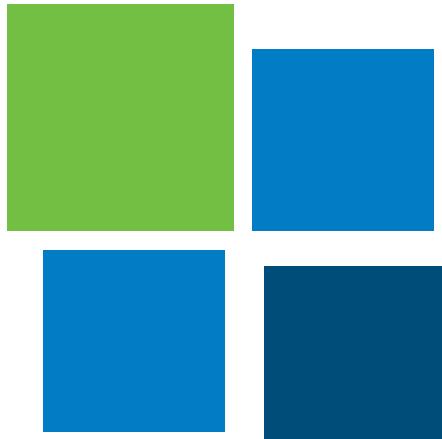

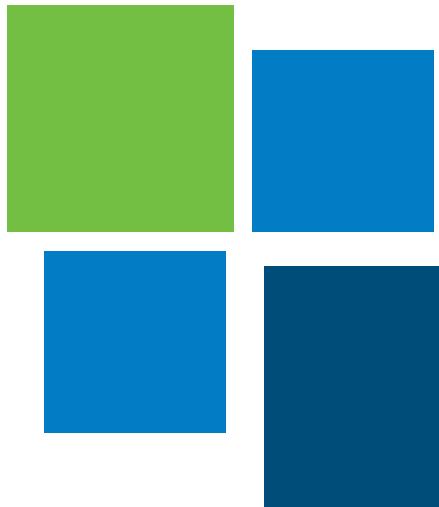
