City Selection Appointment May 2024 Opportunity Notice

Orange County Parks Commission

Position:

- **(1) Individual** to serve as the **Coastal City Representative** on the Commission. Interested candidates must be a Mayor/City Council Member and **shall be** a resident of the Cities of Seal Beach, Huntington Beach, Newport Beach, Laguna Beach, Dana Point or San Clemente. To secure this seat, the candidate must obtain votes by the majority of the City Selection Committee (per County Ordinance). This appointment is for a 4-year term which will begin June 1, 2024 and expire May 31, 2028. This seat is currently held by Erik Weigand, Newport Beach City Council.
- **(1) Individual** to serve as the **Inland City Representative** on the Commission. Interested candidates must be a Mayor/City Council Member and shall **not** be a resident of the Cities of Seal Beach, Huntington Beach, Newport Beach, Laguna Beach, Dana Point or San Clemente. To secure this seat, the candidate must obtain votes of the majority by the City Selection Committee. This appointment is for a 4-year term which will begin June 1, 2024 and expire May 31, 2028. This seat is currently held by Dave Shawver, Stanton City Council.

Objective: Acts as an advisory board and makes recommendations to the Board of Supervisors regarding plans and policies for the acquisition, development, maintenance and operation of the regional harbors, beaches and parks of the County.

Responsibilities: To advise the Board of Supervisors on any matter pertaining to harbors, beaches, and regional parks, and other matters referred by the Board concerning open space, trails, community and neighborhood parks and recreational activities.

Time Commitment: 1-2 hours a month, plus three day-long Saturday field trips per year.

Term Length: 4-year term
