## Right to Life Committee of New Mexico PAC

Questionnaires were sent to candidates in statewide Candidates are rated primarily based on their answers to our questionnaire with some deference to previous pro-life voting records in tiebreakers. Since every candidate who did not respond was personally contacted and urged to send in their responses, candidates who failed to respond were automatically rated “failed to answer”, regardless of pro-life record or views. Party affiliation was not a factor in any rating but is listed here only for identification purposes.
