

### **HYAWAY TRANSPORTATION PRIVACY POLICY**

At Hyway Transportation ("Hyway" or "we"), we respect your privacy. This Privacy Policy ("Policy") governs how and why Hyway collects, shares, discloses, and protects personal information from users ("User," "Users," or "you") of the <a href="https://www.hywaytransportation.com">www.hywaytransportation.com</a> ("Website"), as well as User rights respecting their personal information. By using the Website or otherwise accepting cookies (as described below), you consent to Hyway's collection, disclosure, or sharing of any personal information about you in accordance with this Policy, and accept all other practices described herein.

This Policy may be changed at any time without advance notice. Upon making any changes, we will update the "Last Updated" date at the end of this page. Any changes will take effect immediately upon their posting to our Website and apply to activities and information going forward (but not retroactively).

### 1. DEFINITIONS

- A. "Personal Data" refers to any direct or indirect information relating to an individual person, which allow identification of a specific person. Examples include, name, address, telephone, email address, or any other data specific to you.
- B. "Agent" refers to a third party that collects or uses Personal Data to perform task on the behalf of Hyway.

## 2. AGE REQUIREMENTS

A. This Website is not directed to or intended for individuals under the age of eighteen (18). Hyway does not intentionally or knowingly collect, use, or disclose Personal Data or other information on this Website or otherwise from individuals we know are under 18. We request that these individuals under 18 years of age do not provide Personal Data or other information to Hyway.

#### 3. CATEGORIES OF PERSONAL DATA THAT WE COLLECT & DISCLOSE TO AGENTS

- A. In the past twelve (12) months, Hyway has collected, and/or disclosed to Agents, Personal Data of Users that may include any of the following information:
  - I. User's name, postal address, email address, IP address, telephone number;
  - II. Characteristics of protected classifications under applicable law;
  - III. Geolocation Data;
  - IV. Professional or employment-related information; and/or
  - V. Education information.

# 4. HOW AND WHY WE SHARE YOUR PERSONAL DATA

- A. Hyway does not sell your Personal Data to any third parties.
- B. We use your Personal Data to improve your experience with Hyway and our Website. Examples include, but are not limited to: responding to quote requests, marketing and advertising services, conducting surveys, notifying users about changes to our Website, Hyway news or services, presenting our Website and relevant content to you.
- C. We may disclose or share your Personal Data in the following ways:
  - I. We will share your Personal Data with Agents with whom Hyway is under contract. For example, we retain an Agent to help Hyway develop marketing and/or advertising content you may find useful. To better serve our Users relevant content, we may share your Personal Data with these Agents.
  - II. We may disclose Personal Data when necessary to comply with federal, state, or local laws, or to protect the rights, property, or safety of Hyway, our users, our employees or others.
  - III. We may disclose or provide a User's Personal Data in connection with the exercise of legal claims, defend legal claims or in response to a valid subpoena, warrant, court order or other legal process.
  - IV. No mobile information will be shared with third parties or affiliates for marketing or promotional purposes. All categories described in this Privacy Policy exclude text messaging originator opt-in data and consent; this information will not be shared with any third parties. End users can opt out of receiving further messages by replying STOP or ask for more information by replying HELP. Message frequency may vary. Message and data rates may apply.
