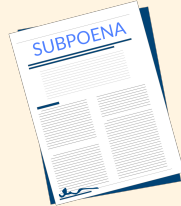

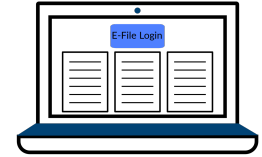

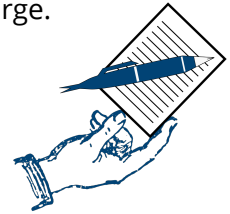
Mobile Copy Services
