BEEF-PAC Sweepstakes OFFICIAL RULES – 2023

Important: Please read these Official Rules before entering this promotion (the “Promotion”). By participating in the Promotion, you agree to be bound by these Official Rules and represent that you satisfy all of the eligibility requirements below. NO PURCHASE, PAYMENT OR FINANCIAL CONTRIBUTION OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS PROMOTION.

1. Eligibility. PURCHASE, PAYMENT OR FINANCIAL CONTRIBUTION WILL NOT INCREASE ODDS OF WINNING. PROMOTION VOID WHERE PROHIBITED. 3. Promotion Period. The Promotion begins on Thursday, June 15, 2023, at 8:00 a.m. and ends on Monday, October 9, 2023, at 8:00 p.m. (the “Promotion Period”). All entries must be received during the Promotion Period to be eligible to win the prize.

4. Prize and Delivery. One (1) ticket enters an individual into one (1) prize drawing to be conducted on Monday, October 9, 2023, during the TCFA Annual Convention at the Gaylord Texan in Grapevine, Texas. Winner will receive the following prize (the Prize): one (1) 2023 Polaris Sportsman 850 Premium. Winner must arrange delivery with the Sponsor and possession of the Prize must be completed on or before Monday, October 23, 2023.

Participants may enter as follows: (a) Free Entry Method Via In-Person Submission: To enter via in-person submission, complete BEEF-PAC Sweepstakes Entry Form at any location where Sponsor is collecting such entries to enter the BEEF-PAC Sweepstakes during the Promotion Period. At such locations, BEEF-PAC may ask for donations of up to \$5,000 from individuals per calendar year to BEEF-PAC, but will not be asking for, and will not accept in connection with this solicitation, donations in any amount from registered federal lobbyists, registered foreign agents, federal political action committees, or

minors under the age of 21. Contributions in any amount from corporations, labor organizations, national banks, federal contractors, and foreign nationals are prohibited. No minimum contribution is necessary to enter the BEEF-PAC Sweepstakes and making a contribution will not increase your chances of winning the prize. (b) Entry Via Online Submission: To enter via online submission, visit the BEEF-PAC webpage to complete BEEF-PAC Sweepstakes Entry Form after logging into the member portal at www.tcfa.org. For All Entry Methods: Failure to submit all required information in the manner required in these Official Rules and/or any entry or contribution form may result in disqualification. Proof of contribution will not be deemed to be proof of receipt of entry by Sponsor. All entrants and entries are subject to verification by Sponsor. Entries will not be acknowledged or returned. By entering the Promotion, you consent to being placed on an e-mail mailing list to receive information from Sponsor and for other purposes in accordance with Sponsor's Privacy Policy. Any provision of these Official Rules deemed unenforceable will be enforced to the extent permissible, and the remainder of these Official Rules will remain in effect.
