Greetings!

The Health Care Collaborative of Rural Missouri and Live Well Community Health Centers are excited to be the host of the second annual, one-day public health service event for adults on Saturday, November 4, 2017 from 9:00 am to 2:00 pm. The event will be held in the East Gym at Lafayette County C-1 High School located at 805 W 31st Street in Higginsville. This event is for underserved and uninsured adults that need connected to various services in their community and region. Last year, the majority of people were from Lafayette County BUT we did have quite a few from Pettis, Saline, Carroll, Ray and Johnson Counties.

We will have dentists available to do free dental extractions (no cleanings). There will also be free haircuts, various health and mental health screenings, Veteran's services, vouchers for driver's licenses and birth certificates, manicures, chiropractic corrections, photographs and we hope to have you and many other services by 55 or 60 organizations (such as yours) to provide free services and disseminate information to Guests connecting them to resources that day and raising awareness of what is available to them and others they know for future use.

Each full booth will have a table and 1 or 2 chairs. If you need a private area for consultation, please let us know so we can be certain you have the correct access. All booths must be set-up between 7:45 and 8:30 am Saturday morning the day of the event and if you participate, you **MUST STAY** until the event ends **AND START YOUR TEAR-DOWN NO EARLIER THAN 2:00 pm on Saturday**. We anticipate 275 to 325 Guests to attend (last year, there were 280). We will help a LOT of people, meet many needs and give a LOT of hope! A free lunch, bottled water and snacks will be provided Guests, Volunteers and Service Providers.

We have implemented a new and different process encouraging Guides and Guests to engage with every single Service Provider booth—we have seen GREAT things happen as a result! We tried this new process at several recent 2017 events and have experienced increased interaction by 300%.

Your organization is invited to participate by providing health information, informational/interactive booths, social services, health screenings OR any other service that can be delivered that day. Attached you will find a response sheet to return by mail, email or fax. **Please return your participation sheet ASAP so that we plan accordingly.** However, the deadline will be Friday, October 20, 2017 to be included in the map and other material—BUT the sooner the better!

This event is being organized by the Health Care Collaborative of Rural Missouri and Live Well Community Health Centers in collaboration with the Lafayette County Social Services Committee, many service providers, churches, civic groups, business people, college students and citizens of the area.
