



Storm Update: Monday, April 17, 6:30 p.m.

Additional rainfall this afternoon raised water levels in some already hard-hit areas of the City. An estimated 3.3 inches of rain fell today. The City's stormwater system is designed to handle three inches in a 24-hour period.

There are currently 27 vactor/pumping trucks removing water in areas across the City. Other crews are deployed to assist with muck removal left behind by floodwater. De-mucking and street sweeping activities are expected to be completed by the end of this week.

DAMAGE ASSESSMENTS

Today, the Florida Division of Emergency Management requested teams from FEMA to conduct in-person joint Preliminary Damage Assessments (PDA) in Fort Lauderdale. The assessments will determine what federal assistance may be made available for impacted residents.

FEMA assistance is dependent upon the damage from this incident reaching a certain threshold. If you had 12 or more inches of water in the interior of your home, please call and report it to 954-828-8000.
