A PROJECT IN JEFFERSON COUNTY APPROVED FOR FEDERAL TAX CREDITS

In September 2016 the Mack Truck Garage project in Birmingham, Alabama, was approved by the National Park Service for the twenty-percent federal rehabilitation tax credit program.

The Mack Truck Garage is a contributing resource in the Southside Historic District in Birmingham.



Constructed in 1924, the one-story masonry structure was built for the Mack International Truck Company as a branch headquarters and garage. It was later expanded in 1946 as the Liberty Motors dealership increased their service department.



DataPerk, a technology company, began rehabilitating the building in 2014. The former industrial space was transformed into a vibrant workplace and event venue.

The band of infilled storefront and window openings along 6th Avenue South were restored to their historic appearance. Natural light plays a big role in creating a productive work

environment. The lofty interiors with exposed steel trusses and wood roof joists are highlighted in both the office and event spaces with a thoughtful design which allows the historic character of the building to dominate.

The National Park Service oversees the Preservation Tax Incentive program jointly with the Internal Revenue Service (IRS). To qualify, the building has to be listed in the National Register, either individually or in a historic district. Additionally, the property must be used for income-producing purposes.
