

Trip Description: W-SSOC Ski Vacation, Panorama, BC, Canada Saturday-Saturday, March 7- 14, 2026

Eligibility: Open to Members in Good Standing of W-SSOC beginning June 1, 2025. Members of Authorized Clubs of the Crescent Ski Council must join W-SSOC. Membership must be current from time of sign-up through end of Trip.

Requirements to be placed on, and stay on, the Trip: 1) Eligibility met; 2) Trip Application current; 3) Payments current; 4) Space (lodging (and air, if applicable)) available and 5) Compatible roommate(s)/condo-mates available. See Trip Application for additional info.

Full Package #1A, #2A and #1B/2B include ground transfers YYC-Panorama-YYC, 7 nights lodging in double occupancy bedroom in 2BR/2B condo at Panorama Springs Lodge (slopeside/ski-in/ski-out, 2000 Panorama Drive, Panorama, British Columbia V0A 1T0); welcome party; other parties, W-SSOC Administration. Trip Price Guarantee and Caveats (Supplements to Terms & Conditions—See Trip Application):

The cost of the Group Air is guaranteed for the number of air seats held (34) and requires a minimum of 10 participants to use the air. Trip Prices are guaranteed within the limits of available spaces as described herein. If trip size falls below 20 participants, an extra charge for ground transfers will be added.

Late sign-up: After November 20, 2025, W-SSOC may increase any Trip Price (double occupancy) up to max. \$150 per person.

Payment Schedule:

- 1st: \$350 due at sign-up.
- 2nd: \$500 due August 21, 2025.
- 3rd: \$500 (if no Group Air) or \$881 Group Air, due October 16, 2025.
- 4th: Package Balance, including any options or price adjustments, due November 20, 2025.

W-SSOC Cancellation Policy: Refer to the W-SSOC Panorama'26 Trip Application for full details.

1. No fee for cancellation received on or before August 21, 2025, or, for Group Air, before issuance of electronic tickets (exact date varies; typically, about 95 days prior (Tue., Dec. 2, 2025, is 95 days)).
2. \$100 fee for cancellation of Group Air after electronic ticketing.
3. \$25 fee for cancellation of basic package August 18 through November 20, 2025.
4. \$50 fee + unrecoverable moneys (e.g., an unfilled lodging space) not to exceed trip cost for cancellation after Nov. 20, 2025. Unrecoverable moneys increase as commitments are made for you.
5. If your space is filled after November 20, 2025, fee is \$50 + air ticket rewrite fee (if applicable) + any direct expenses associated with filling your space (if applicable, e.g., phone, FedEx, airline name-change fee).
