Available Hours for Pool Parties: Parties are booked for 4-hour blocks of time within the timeframes listed below. Pool parties will end when the regular amenities close at 9:00 PM.

1. Friday 6 PM – 9 PM
2. Saturday 8AM-12PM, 1PM-5PM, 6PM-9PM; please select a 4-hour time block (if applicable.)
3. Sunday 8AM-12PM, 1PM-5PM, 6PM-9PM; (4 hrs. total); please select a 4-hour time block.

- The Pool Party Rules and Acknowledgment Form **MUST** be signed before the party may take place.
- **Pool Parties will be an additional \$350.00 to be paid at the time the reservation is made.** Wristbands for the party will be included in the price for the pool party. Lifeguards are no longer required for pool parties.
- The Homeowner **MUST** be present at the pool during the party at all times.
- The slide is open from 12PM-7PM during the summer **ONLY**: Tuesday-Sunday. Mondays reserved for cleaning.
- The Clubhouse **MUST** be rented in order to have a pool party.
- The Homeowner must identify the party as a pool party at the time of the reservation.
- The pool party must **NOT** exceed the clubhouse rental timeframe and **will end** by pool closing time if the party hours extend past the pool hours.
- **Up to 15 guests** will be allowed for a pool party during your reservation time only. This does not give the reservation the exclusive use of the pool. (Total guests not to exceed a maximum of 15 people, to include swimmers and non-swimmers, and babies to adults)

- The pool party must be paid for in advance, before the date of the party. Pool monitors will not accept any payments.
- Pool party wristbands will be issued to the homeowner prior to the event date. Wristbands must be picked up at the office prior.

Homeowners and guests will abide by and adhere to the **signed** Recreation Center and Pool Use Policy. Clubhouse Use Release and Indemnification Acknowledgement and Agreement

☐ I/We understand that any violation of the agreement allows the Alamo Ranch Community Association (ARCA) to keep a portion or all of the deposit. If security deposit amount is not sufficient to correct any damage, the above named will be responsible for the remaining amount.
