**Market animal entry information for the 2021 Silver Dollar Fair is available from 4-H or Grange Leaders, FFA Advisors, 4-H Cloverleaves, Silver Dollar Fair Main Office or at [www.silverdollarfair.org](http://www.silverdollarfair.org).**

*The Silver Dollar Fair Board of Directors expressed their commitment to youth exhibitors, and encourage market animal project participation with confidence, and with the assurance the fair will provide a venue for market animal projects that are evaluated to be market acceptable. Those that meet grading requirements and adhere to entry limits, deadlines, and Silver Dollar Fair Local Rules, will be sold at a 2021 Junior Livestock Auction.*

➤ ***Exhibitors, Parents & Leaders, please read local rules prior to submitting a market entry. 2021 Local Rules, Independent Packet & Drug Form are available at [www.silverdollarfair.org](http://www.silverdollarfair.org). All State & Local rules apply.***

- **Market Steer entries opened 8:00 a.m. Sept 16** and are limited to 45 market steers. As of today, the entry limit has not been met and entries will close **5:00 p.m. Jan. 27, 2021** (120 day ownership deadline) & proof of ownership due (photos, bills of sale) by 5 pm or entries will be disqualified.
- **Market Goat, Hog & Lamb entries open 8:00 a.m. Monday Jan. 4, 2021** and are limited to 210 market lambs/goats combined & 270 market hogs. If entry limits are exceeded, a lottery will be put into effect for lambs/ goats combined, and hogs to determine eligibility for the Silver Dollar Fair. All entries must be received by **12:00 noon Monday, Jan 11<sup>th</sup>** to be eligible for the lottery. Please contact your FFA Advisor, 4H or Grange Leader, the Fair Office or see our website for lottery information as it may affect **every** market lamb, goat or hog entry.
  - **Entries close 5:00 p.m. March 29, 2021** (60 day ownership deadline) & proof of ownership due (photos, bills of sale, scrapie information, breeder information) by 5 pm or entries will be disqualified. **Entry fee \$15** per entry.
- **Rabbit Meat Pen entries open 8:00 a.m. Monday Feb 1, 2021** are limited to 40 meat pens. If entry limits are exceeded, a lottery will be put into effect to determine eligibility for the Silver Dollar Fair. All entries must be received by **12:00 noon on Feb 8<sup>th</sup>** to be eligible for the lottery. Please contact your FFA Advisor, 4H or Grange Leader, the Fair Office, or see our website for lottery information as it may affect **every** rabbit meat pen entry.
  - **Entries close 5:00 p.m. April 27, 2021** (30 day ownership deadline) & proof of ownership due (photos, bills of sale, tattoos) by 5 pm or entries will be disqualified. **Entry fee \$15** per entry.

**2021 ONLINE ENTRIES -** This year, all market entries can be processed online through the link on our website and while online payment was not an option for Market Steers, online payment is set up for all other market exhibitors. If you choose to enter online, please also complete the Exhibitor/Parent/Guardian Release of Liability form which is also accessible through our website. While we encourage you to try our new online entry process, hard copy entries will still be accepted by mail or dropped through the mail slot at the office.

➤ **INDEPENDENT EXHIBITORS:** Independent Exhibitor packets are available at [silverdollarfair.org](http://silverdollarfair.org) or in the Fair Office. It is your responsibility to obtain the packet & meet all requirements to show your animal(s) at the Silver Dollar Fair & be eligible for the Junior Livestock Auction. All State and Local Rules apply.

➤ Introduced in 2020 – There is an opportunity for Junior Ag Equipment Exhibitors to be eligible for the Junior Livestock/ Ag Equipment Auction. Individual or Group Exhibitors must enter their project no later than **5:00pm on March 5, 2021**. Individual Exhibitors may have an Ag Project **OR** a Livestock entry, not both.
