Article VIII, Section 23.3(12) & (16). Kansas City Regional Association of REALTORS®, St. Louis REALTORS®, and St. Charles REALTORS®, collects contributions as an agent RPAC. 65% of your PAC donation goes to RPAC, while 35% stays locally.
