Updates

Felony Murder| Felony Hit & Run *ARREST – On July 26, investigators identified and obtained arrest warrants for the suspect sought in connection to the fatal hit & run crash that occurred in the parking lot of the Oasis at Montclair Apartment complex located in the 16400 block of Stedham Cl. in Dumfries (22025) on July 20. Later that day, the accused was located and arrested by Virginia Beach City police. The investigation revealed the accused was attempting to steal the victim's vehicle when the victim was struck causing fatal injuries. At this time, there is no known connection between the victim and the accused. No other suspects are being sought in the investigation.

Fatal Hit & Run Crash Investigation *SUSPECT SOUGHT [Previously Released] – On July 22, crash investigators were notified that the 37-year-old man struck by a hit & run driver in the parking lot of the Oasis at Montclair Apartment complex located in the 16400 block of Stedham Cl. in Dumfries (22025) on July 20, had died. The victim remained hospitalized until succumbing to his injuries sustained after being struck by a suspect who stole his 1999 gold Lexus RX 300. On the morning of July 23, officers were on an unrelated call when they located the vehicle sought in connection to the incident on Ashdale Cl. In Woodbridge. Additionally, investigators obtained surveillance images of a man believed to be involved in the incident which were obtained in the area of the incident on Stedman Cl. **Investigators with the Violent Crimes Unit are actively investigating the incident to determine what led up to the encounter and are seeking to speak with anyone who can identify the suspect or otherwise aid in the investigation.** More information will be released when available. The investigation continues.

**Continuation from the investigative update on the previous page.*

Felony Hit & Run [Previously Released] – On July 20 at 6:53PM, officers responded to the Oasis at Montclair Apartment complex located in the 16400 block of Stedham Cl. in Dumfries (22025) to investigate a hit and run crash. The investigation revealed the victim, a 37-year-old man, was approached by an unknown individual while he was outside of his vehicle. At one point during the encounter, the suspect got into the victim's vehicle, a gold Lexus SUV, and began to drive in reverse. The victim grabbed onto the vehicle before the SUV struck a separate unoccupied vehicle before moving forward. As the SUV continued forward, the victim was thrown off and subsequently run over. The suspect drove the stolen SUV out of the area prior to police arriving on the scene. The victim was treated at an area hospital for life-threatening injuries. The investigation continues as detectives attempt to identify and locate the suspect.

Armed Robbery *SUSPECTS IDENTIFIED | ARREST [Previously Released] – While continuing to investigate the case, officers identified the two men involved in the robbery that was reported to have occurred in the 7800 block of Brookview Ct. in Manassas (20109) on April 1. The investigation revealed the suspects had driven the victim's vehicle after he had been rendered unconscious. Some items reportedly stolen during the incident were later recovered. Following the investigation, officers obtained arrest warrants for the two male suspects and the victim's female acquaintance. In late July, the two male suspects, identified as Jose Luis **GOMEZ OCHOA** and Jordy Antonio **BAIRES-BONILLA**, were arrested. Attempts to locate the female acquaintance, identified as Fatima **CRUZ CRUZ**, have been unsuccessful. The U.S. Marshals Fugitive Task Force assisted in the apprehension of one of the suspects.

Armed Robbery [Previously Released] – On April 1 at 1:29PM, officers responded to investigate a robbery that was reported to have occurred in the 7800 block of Brookview Ct. in Manassas (20109) earlier that morning at approximately 2:00AM. The investigation revealed the victim, a 17-year-old male juvenile, was meeting a female acquaintance in the above area when two men entered their vehicle. During the encounter, the victim was struck by both men and the female acquaintance before one of the men retrieved a firearm. The victim was physically struck with the firearm, rendering him temporarily unconscious. Later that morning, the victim woke inside the vehicle and went to an area hospital where police were contacted. A phone and purse were reported missing.

Preliminarily, the incident does not appear to be random.

The investigation revealed the victim, a 44-year-old woman, and a family member, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused grabbed the victim's neck before leaving the residence. Minor injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as Dewayne Lawrence **JAMES**. Attempts to locate the accused have been unsuccessful.

Aggravated Assault - On July 27 at 7:04PM, officers responded to Round 1 Bowling and Amusement inside Potomac Mills located at 2700 Potomac Mills Cl. in Woodbridge (22192) to investigate a fight. The investigation revealed the victim, a 13-year-old male juvenile, was involved in a physical altercation with four other juveniles. During the encounter, the victim was knocked to the ground where one of the suspects took the victim's hat while the other suspects attempted to take other property. At one point during the encounter, an employee intervened and separated the parties. Minor injuries were reported. The suspects were described as male juveniles wearing all dark-colored clothing.

Reckless Handling of a Firearm - On July 27 at 8:23PM, officers responded to investigate a shots fired call that was reported to have occurred in the 7400 block of Backus Ln. in Manassas (20111) earlier that day. The investigation revealed around 5:24AM, a man was seen firing a handgun towards another man. The parties separated and no additional shots were fired. No injuries or property damage were reported. The parties involved were not immediately identified.

Reckless Handling of a Firearm - On July 26 at 5:44PM, officers responded to the River Oaks Apartments located in the 16700 block of Diamondleaf Oak Dr. in Woodbridge (22191) to investigate found property. The investigation revealed shell casings were located near a wooded area. Earlier that morning, around 2:48AM, officers responded to the above area for reports of gunshots. No evidence of a shooting was located at that time. No injuries or property damage were reported.

Commercial Burglary - On July 28 at 4:34AM, officers responded to Naz's Halal Food located at 14230 Smoketown Rd. in Woodbridge (22192) to investigate a burglary. The investigation revealed forced entry was made into the business through the glass portion of the front door. The suspect took money from the register and left through the rear door. A police K-9 searched the area for the suspect who was not located. The suspect was described as a man wearing dark-colored clothing and a mask.

Strangulation (Domestic Related) – On July 28 at 7:02PM, officers responded to a residence located in the 12400 block of Eden Ln. in Woodbridge (22192) to investigate a domestic dispute. The investigation revealed the victim, a 56-year-old woman, and a family member, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused struck the victim before grabbing her neck. When a 19-year-old male family member intervened, the accused grabbed his arm before the parties separated. Minor injuries were reported. Following the investigation, the accused, identified as Mohamed Kameleddine **AMARA**, was arrested.
