### Updates

**Fatal Hit & Run Crash Investigation \*SUSPECT SOUGHT** - On July 22, crash investigators were notified that the 37-year-old man struck by a hit & run driver in the parking lot of the Oasis at Montclair Apartment complex located in the 16400 block of Stedham Cl. in Dumfries (22025) on July 20, had died. The victim remained hospitalized until succumbing to his injuries sustained after being struck by a suspect who stole his 1999 gold Lexus RX 300. On the morning of July 23, officers were on an unrelated call when they located the vehicle sought in connection to the incident on Ashdale Cl. In Woodbridge. Additionally, investigators obtained surveillance images of a man believed to be involved in the incident which were obtained in the area of the incident on Stedman Cl. **Investigators with the Violent Crimes Unit are actively investigating the incident to determine what led up to the encounter and are seeking to speak with anyone who can identify the suspect or otherwise aid in the investigation.** More information will be released when available. The investigation continues.

**Felony Hit & Run [Previously Released]** - On July 20 at 6:53PM, officers responded to the Oasis at Montclair Apartment complex located in the 16400 block of Stedham Cl. in Dumfries (22025) to investigate a hit and run crash. The investigation revealed the victim, a 37-year-old man, was approached by an unknown individual while he was outside of his vehicle. At one point during the encounter, the suspect got into the victim's vehicle, a gold Lexus SUV, and began to drive in reverse. The victim grabbed onto the vehicle before the SUV struck a separate unoccupied vehicle before moving forward. As the SUV continued forward, the victim was thrown off and subsequently run over. The suspect drove the stolen SUV out of the area prior to police arriving on the scene. The victim was treated at an area hospital for life-threatening injuries. The investigation continues as detectives attempt to identify and locate the suspect.

**Assault with a Caustic Substance (Domestic Related) [Previously Released]** – On June 26 at 9:07PM, officers responded to the Elevations One Apartments located in the 14300 block of Bellona Rd. in Woodbridge (22191) to investigate a domestic dispute. The investigation revealed the victim, a 26-year-old man, and an acquaintance, identified as the accused, were involved in a verbal altercation in the parking lot that escalated. During the encounter, the accused sprayed the victim in his face and upper body with an unknown substance before driving away in her vehicle. The victim was treated at the scene for minor injuries. Following the investigation, officers obtained arrest warrants for the accused, identified as Tahjaia **CORUM-HILL**. Attempts to locate the accused have been unsuccessful.

The investigation revealed the victim, a 20-year-old woman, and a family member, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused struck the victim and prevented her from contacting emergency services. The accused then prevented the victim from leaving the residence and grabbed her neck before the parties eventually separated. Minor injuries were reported. Following the investigation, the accused, identified as Brayan **HERNANDEZ**, was arrested.

**Child Neglect** – On July 22 at 8:14AM, officers responded to the Rolling Brook Village Apartments located in the 12700 block of Wood Hollow Dr. in Woodbridge (22192) to investigate a found child. The investigation revealed the victims, a 3-year-old boy and a 1-year-old boy, were left unattended for an extended period of time by their father, identified as the accused. Officers responded to the apartment complex when a Good Samaritan located the children outside unsupervised. While investigating the incident, the accused returned to the residence. The children did not appear to be injured and were released to the custody of known parties. Following the investigation, the accused, identified as Sekani Trent **CAIN**, was arrested.
