### Updates

**Homicide Investigation \*SUSPECT VEHICLE SOUGHT** – Detectives are seeking the vehicle involved in the homicide that occurred in the area of Pineview Rd and Cregger Ln in Manassas (20111) on July 18. The vehicle was seen leaving the area shortly after the shooting that killed an 18-year-old woman. The vehicle is described as a 2017 blue Hyundai Elantra, sports edition with Virginia license plate TVT-8777. The vehicle is possibly in the Leesburg/Loudoun County area. Detectives are still actively investigating the incident to determine what led up to the shooting and are seeking to speak with anyone who can aid in the investigation. More information will be released when available. The investigation continues.

**Homicide Investigation [Previously Released]** – On July 18 at 8:23PM, officers responded to the area of Pineview Rd and Cregger Ln in Manassas (20111) to investigate a shooting. Officers arrived on the scene and located an 18-year-old woman in a nearby wooded area suffering from gunshot wounds to the upper body. The woman was pronounced dead on the scene. No other injuries or property damage were reported, and no suspects have been located at this time. Detectives are actively investigating the incident to determine what led up to the shooting and are seeking to speak with anyone who can aid in the investigation. **Preliminarily, the incident does not appear to be random.** More information will be released when available. The investigation continues.

## Incidents

**Felony Hit & Run** – On July 20 at 6:53PM, officers responded to the Oasis at Montclair Apartment complex located in the 16400 block of Stedham Cl. in Dumfries (22025) to investigate a hit and run crash. The investigation revealed the victim, a 37-year-old man, was approached by an unknown individual while he was outside of his vehicle. At one point during the encounter, the suspect got into the victim's vehicle, a gold Lexus SUV, and began to drive in reverse. The victim grabbed onto the vehicle before the SUV struck a separate unoccupied vehicle before moving forward. As the SUV continued forward, the victim was thrown off and subsequently run over. The suspect drove the stolen SUV out of the area prior to police arriving on the scene. The victim was treated at an area hospital for life-threatening injuries. The investigation continues as detectives attempt to identify and locate the suspect.

**Vehicle Description:**

A 1999 Gold Lexus RX 300 with Virginia license plate: TUW8710

With damage to the rear left bumper area, taillight assembly, and possibly the rear left rim, and two 'Baby on board' stickers on the rear of the vehicle

**Shooting Investigation** – On July 21 at 5:35AM, officers responded to the area of Smoketown Rd. and Purdham Dr. in Woodbridge (22192) to investigate a shots fired call. The investigation revealed the victims, a 19-year-old man and woman, were driving in the above area when an occupant in a black Honda Civic fired at their vehicle. When the victim attempted to drive away, the Civic followed and fired additional rounds as the vehicles traveled along Old Bridge Rd. near Smoketown Rd. Eventually, the victims stopped at a local business while the suspect vehicle continued driving away. The victims reported minor injuries from shattered glass. No additional injuries or property damage were reported.

**Armed Robbery** – On July 20 at 3:16AM, officers responded to the 10200 block of Irlongate Way in Manassas (20109) to investigate a robbery. The investigation revealed the victim, a 40-year-old man, was approached by four unknown men. During the encounter, the suspects brandished a knife and took the victim's wallet before the parties separated. Officers and a police K-9 searched the area for the suspects who were not located. No injuries were reported. The suspects were only described as short Hispanic males.

**Brandishing of a Firearm** – On July 20 at 9:40PM, officers responded to the area of Mapledale Ave. near Meadowbrook Rd. in Woodbridge (22193) to investigate a brandishing. The investigation revealed the victims, a 39-year-old man and a 43-year-old woman, were driving in the above area when they observed a dark-colored Lexus stopped on the side of the road. As the victims neared the Lexus, multiple occupants got out of the vehicle and brandished firearms toward the victims. The victims quickly drove out of the area and contacted the police. No shots were fired, and no injuries were reported. The investigation continues as officers attempt to identify the individuals involved in the incident.

**Commercial Burglary** – On July 21 at 1:25AM, officers responded to the ABC Store located at 11010 Sudley Manor Dr. in Manassas (20109) to investigate an alarm activation. Video surveillance revealed two masked men shattered the front glass window with an unknown object to enter the business. The suspects took multiple bottles of alcohol before leaving the business. A police K-9 searched the area for the suspects who were not located. The suspects were described as a white male wearing a black t-shirt and an unknown race male wearing a white t-shirt.

The investigation revealed the victim, a 39-year-old man, and a family member, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused grabbed a knife and attempted to stab the victim before another family member intervened. The accused then kicked a 17-year-old family member before the parties separated. Minor injuries were reported. Following the investigation, the accused, identified as a **16-year-old female juvenile**, was arrested.

**Assault & Battery on a Law Enforcement Officer [LEO]** – On July 20 at 11:13PM, officers responded to the Coverstone Apartments located in the 10900 block of Coverstone Dr. in Manassas (20109) to investigate an unlawful entry. During the investigation, officers detained a man, later identified as the accused, for public intoxication and for entering an unsecured apartment. While the accused was receiving treatment for an injury sustained while entering the apartment, he kicked a firefighter multiple times before being transported to an area hospital. At the hospital, the accused head-butted an officer twice before being re-secured without further incident. Minor injuries were reported. Following the investigation, the accused, identified as Neyssar **BONILLA AFARO**, was arrested.
