## New Board Sworn-In For a 4 Year Term

On January 6th, Prince William County's eight elected county supervisors were ceremonially sworn in at the Hylton Performing Arts Center.

Five Supervisors, including Andrea Bailey (Potomac), Kenny Boddye (Occoquan), Margaret Franklin (Woodbridge), Ann Wheeler (Chair At-Large), and Yesli Vega (Coles) were sworn in for the first time, alongside returning members Victor Angry (Neabsco), Pete Candland (Gainesville), and Jeanine Lawson (Brentsville).

The five newly elected supervisors have large shoes to fill and 76 years worth of combined experience to replace from their predecessors.

This does not include the 37 years of experience lost in 2019 with the passing of Supervisor John Jenkins, the longest serving supervisor in Prince William County history.

The new board immediately made history on two fronts in that it was the first time in it's history that the racial makeup would reflect Prince William County's majority-minority status (four African-Americans and one Hispanic) and the first time that women made up a majority of the board.

One of the first orders of business for the new board at their inaugural January 7th meeting included the election of Neabsco District Supervisor, Victor Angry, as Vice-Chair, and Woodbridge Supervisor, Margaret Franklin, Chair Pro-Tempore.



# Chair Wheeler Gives 'State of the County' Address

On January 7th, new Prince William Board of County Supervisors Chair, Ann Wheeler, delivered her first 'State of the County' address before a packed house at the McCoart County Government Building.

In her inaugural address, Chair Wheeler said she would focus her efforts on school funding, transportation, and economic development.

Regarding education and school funding, Wheeler said, "we must invest in our public schools and capital infrastructure to make Prince William County a community where families throughout Northern Virginia seek to locate in order to provide advantages for our children's future."

Chair Wheeler then addressed economic development in the county, stating, "While our economic development efforts have prioritized commercial investment, in the future we need to further increase the number of high wage jobs here in our own community."

On the topic of transportation, Chair Wheeler noted that she would look for ways to help fund the \$355 million dollar road bond approved by county voters in November.

# BOCS Unanimously Votes to Postpone and Table Resolution 10-A

At the January 7th Board of County Supervisors meeting, Chair Ann Wheeler introduced Resolution 10-A as part of the county's legislative goal package sent to the Virginia General Assembly in Richmond.

On a snowy afternoon which resulted in an early release for Prince William County Public Schools, nearly 1,000 residents packed the board chambers and atrium of the McCoart Building.

Due to the large number of attendees, Chair Wheeler limited citizens speaking time to two minutes per person. Most in attendance believed the resolution presented an affront to their Second Amendment right to keep and bear arms and did not want the county to send that message to Richmond.

Of the 135 citizens who signed up to speak only 8 spoke in favor of the resolution.

After several hours of listening to citizen opinion on the resolution, Chair Wheeler opened up the resolution for public discussion amongst her board members. Supervisor Pete Candland (Gainesville) stated his belief that a procedural statute was violated since the resolution was placed on the agenda without a traditional one week notification. The board then sought the opinion of County Attorney, Michelle Robl, on the matter. Ms. Robl pointed out that while the county board's rules of procedure requires a one week notice to place an item on the agenda, it is superseded by another rule which allows the Chair the power to waive the former rule and place whatever item on the agenda they see fit.

Given citizen opposition to the resolution, a motion was made by Supervisor Candland to postpone the vote by a week to allow the citizens and the board more time to consider the proposed resolution. That vote dead-locked at 4-4, with Supervisor Vega voting for the one week delay. After the tie vote, Supervisor Victor Angry (Neabsco), sensing the division amongst the board and the citizens on the resolution made his own 'friendly amendment' to postpone the vote to a future date. Supervisor Angry's motion passed with a unanimous vote of 8-0 to postpone the vote on the resolution until the scheduled January 21st evening session meeting.

Following further pushback from the public on the issue, Supervisor Angry made a motion early during the January 14th meeting to table the resolution and remove it from the January 21st meeting. agenda. After a couple minutes of discussion, the board once again agreed via a unanimous vote to remove the resolution from the following week's agenda. Given that the General Assembly has already been in session for several weeks it seems unlikely that the resolution will be brought up again soon.

Supervisor Vega applauded the back to back decisions of the board on the resolution, while noting that the opinion of the county was unlikely to change minds in Richmond on the issue of the Second Amendment, gun safety, and mental health. "I applaud this unanimous decision by the board and appreciate the leadership and humility exhibited by my colleagues to remove Resolution 10-A from the agenda in the face of such strong citizen opposition. The people spoke and the board listened. I look forward to moving on to the issues this board can control on behalf of our citizens here in the county."





# Supervisor Vega Introduces Proclamation to Make January Slavery and Human Trafficking Prevention Month

I was honored to be asked by Chrissy Marie of Why, Incorporated to introduce a proclamation at our January 14th meeting to make the month of January Slavery and Human Trafficking Prevention Month in Prince William County.

It may seem hard to believe, but human trafficking is a real problem here in Prince William county. Some of you may recall that just last year the Board of County Supervisors heard the testimony of a gentleman who claimed he was randomly propositioned by a pimp at a local restaurant to have sex with an underage girl.

We must be vigilant to identify and root out the scourge of human trafficking from our community. I look forward to working with our local non-profits, county schools and law enforcement to ensure we are protecting the most vulnerable children in our county from being sold into and used for sexual exploitation.

# 2021-2024 Strategic Plan Update

At our January 14th board meeting officials from the Office of Management and Budget presented their draft and recommendations for the 2021-2024 Strategic Plan Development Process. For those unaware of the county's Strategic Plan, it is our four year community-based document adopted by the Board of County Supervisors to lay out the county's vision and directed outcomes for the proceeding four years. The first Strategic Plan was adopted in 1992 and has helped to guide the county's government management approach and provides key policy guidance for service delivery and budgeting priorities. The last Strategic Plan focused on five key issues, including the growing of our local economy, transportation, county residents "wellbeing" or quality of life, public safety, and education and workforce development. All critical issues to maintaining the vibrant community and quality of life we all desire here in Prince William County.

It was clear county staff put a great deal of work into preparing the process and timeline of the plan in their presentation, and I was appreciative of their work.

#### **Citizen Driven Process**

One item which was left out of the draft plan was the omission of citizen appointees to the Strategic Plan Team. For at least the last two Strategic Plan terms each representative from the board of county supervisors has been able to appoint two citizens to the team (comprised of 16 citizens and 4 staff members) which has then drafted a recommended plan for the board to eventually review.

Many of my fellow board members (myself included) expressed concern over the omission of the citizen Strategic Plan Team and believe keeping this team comprised of county citizens in place is a key and necessary part to maintaining a citizen driven process, and not just citizen input.

Staff came back with what they believed was a compromise of 8 citizens and 7 staff members. Supervisor Candland, Supervisor Lawson and I objected to this since it still represents a decrease in citizen input and increases the role of county staff.

#### **Population Growth and Housing Density**

One item I would like to see added to this term's Strategic Plan is the addition of sound housing and population growth goals. Residential development and the population growth which stems from it has a direct impact on all five of the previous term's strategic planning priorities. Adequate planning for those key priorities cannot happen without considering the impact of residential development and population growth. I look forward to working with my colleagues on the board to incorporate sound goals for residential development and population growth as part of this term's plan.

#### **Extending the Timeline**

The draft presentation expressed staff's desire to have the plan voted on and approved by the Board of County Supervisors by the end of this year.

While I certainly understand the desire to have the plan in place to be able to hit the ground running in January 2021, I want to make sure it gets done right. Setting the county's goals for the next four years is important and if it takes a little while longer to get it right then that's ok by me. Five of the eight members of the board just finished their first month in office - which includes me. I believe we can all walk and chew gum at the same time, but with so many important land use decisions coming down the pike this year in addition to working out the details and funding for the bond projects, education, and maintaining a strong economy, I think it would be wise for us to take some additional time to get this right and not rush the process.



## School Choice Week Removed from January 21st Agenda

A proclamation recognizing January 26th-February 1st as School Choice Week in Prince William County was removed from the dais at the January 21st board meeting.

The proclamation would have recognized the importance and value the county places on "high quality traditional public schools, public magnet schools, public charter schools, and non public schools from which parents can choose for their children, in addition to families who educate their children at home."

As the mother of two children in Prince William County Public Schools I am committed to ensuring a quality public education as, recognized by the Prince William Education Association. As a supporter of quality education I also support competition and choice for all our county parents to send their children to a school which best fits their needs.

Strong public schools and non-public schools can exist and thrive side by side and I hope the county will continue to recognize this next year.

## **Animal Shelter Update**

At the January 21st BOCS meeting, County Director of Public Works Tom Bruun provided the board with an update on the county animal shelter, located in the Coles District.

In his brief, Bruun said the shelter would be delayed by at least six months from its initial February 2021 completion date citing construction costs. Thus far, the lowest contract bid for construction of the shelter has come in at \$13.2 million, about 20% higher than the \$10.7 million allotted by the county for construction of the project.

Director Bruun said he hoped to bring forward a contract with cost savings back to the board in the next few weeks. "Getting the animal shelter done right is of great importance to me and this county" said Supervisor Yesli Vega. "I'm hopeful Director Bruun will be able to come back with significant cost savings so we can be good stewards of the tax-payers money while honoring our commitment to building a first-class facility."

## **Coles District Fire Station #6 Ribbon Cutting**

## **Eye on Transparency**

#### **Larger Public Hearing Notice Signs**

Have you ever driven down the Parkway or 234 and wished you could read the fine print on the public hearing notice signs? They can be very hard to read, especially if you're obeying the speed limit on those roads.

Last month, I spoke with the Planning Office about making the signs larger and the font more visible for our citizens interested in public hearings for proposed land use projects here in the county. They were very amenable to the idea and within weeks came back with a couple blueprints that will make the signs you currently see on the side of the road at least 20% larger (I'm pushing for 30% larger but what you see above is a 20% increase).

A pilot program with larger public hearing signs will be unveiled shortly. In addition to the larger sign which will make it easier for residents to stay in the know about these important meetings, the planning office's draft will also increase the size of the font and color scheme to make them more easily readable.

I'm hopeful this citizen inspired change will increase the knowledge of, and resident participation at important county land use meetings.

## Upcoming

#### **Dar Al Noor Mosque Expansion**

The Dar Al-Noor Mosque, located on Hoadly Road between Purcell Road and the Parkway, is requesting a Special Use Permit to expand its current 12,000 square foot structure to 88,276 feet.

The expansion would include three stories with a basement, along with an updated prayer hall, a multi-purpose banquet hall, a youth and senior center, meeting rooms, play areas, daycare, a private school for 200 students, and an auditorium. The expansion may also include a medical center.

The Special Use Permit would allow the applicant to increase its number of prayer rugs from 502 to 1,782, resulting in an increase of daily vehicle trips from 1,761 to 6,250 according to county estimates. Please <u>click here</u> to view the case under "Under Review".

#### Independent Hill Small Area Plan

Encompasses 564 acres of land along Dumfries Road between Colgan High School to the west, Minnieville Road to the east, and Bristow Road to the south. Borders the Landfill, Prince William Forest, and Marine Corps Base Quantico.

Would include a mixed-use Village Center with up to 400 new housing units. Offer a public facility/office land use option. Tech land use option north of Dumfries Road, and a series of parks and other "environmental assets". Please <u>click</u> <u>here</u> to view the case under "Deferred".

#### Kline Farm Development

Located at the corner of Liberia Avenue & the Parkway to Buckhall Road (South/Southeast). Would rezone 92.19 acres from A-1 Agricultural to Planned Business District, Planned Mixed Residential, and Semi-Rural Residential Cluster to develop mixed residential, retail, commercial, office, and recreational uses. A mixture of up to 250 multi-family townhomes and single family detached residential dwellings surrounding a 145,000 square foot commercial center are being proposed.

Twenty-four acres would be devoted to a new school or parkland. In addition, the Comprehensive Plan would be amended for up to forty-nine acres, and a Special Use Permit needed for a CVS pharmacy with a drive through which would also be built. The development would add an additional 9,400 vehicle trips per day to area roads according to Stanley Martin Homes. Please <u>click here</u> to view the case under "Pending".

#### The Preserve at Long Branch (Mid County Park and Estates)

The Preserve at Long Branch, formerly known as Mid County Park and Estates. Would amend the Comprehensive Plan to rezone 325.6 acres out of the Rural Crescent to build 118 homes with sewer in addition to 195.6 acres for open space and a park. # Meet Our Planning Commissioner Dr. Joe Fontanella

As supervisor, I have the responsibility to make many appointments to the various boards, commissions, and committees which serve at the pleasure of the board. Arguably the most important appointment a supervisor here in Prince William County can make is that of planning commissioner.

Land use decisions may not always grab the headlines but they are of paramount importance to the quality of life we all desire here in the county. That's why I'm pleased to announce that shortly after taking office I appointed Retired U.S. Army Colonel, Dr. Joe Fontanella, as my planning commissioner. Following his retirement from active duty in 2011, Joe became Director of the U.S. Army Geospatial Center with the Army Core of Engineers.



He shares my vision for a more balanced approach to land development than what we've grown accustomed to here in Prince William County over the last couple decades. An approach that puts the wishes, desires, and quality of life of our citizens first.

The county's population has doubled over the last twenty-five years, but commercial growth has not kept pace. The rooftops are here. If the county is to ever accomplish our goal of a 35% commercial tax base we must prioritize commercial development over packing high density housing in wherever there's open land.

Joe understands this and I believe he will advocate for a more balanced approach to land use which holds our housing policy decisions in-check while making sure those currently traveling out of the county for work can find a good job right here in Prince William.

What we do in regards to land use and planning has a major impact not only on school overcrowding and traffic, but our public safety, property tax rates, and more.

Joe has served our country admirably and I'm confident he'll serve the Coles District and its interests just as well.
