Updates

Armed Robbery *SUSPECTS IDENTIFIED | ARREST – While continuing to investigate the case, officers identified the two men involved in the robbery that was reported to have occurred in the 7800 block of Brookview Ct. in Manassas (20109) on April 1. The investigation revealed the suspects had driven the victim's vehicle after he had been rendered unconscious. Some items reportedly stolen during the incident were later recovered. Following the investigation, officers obtained arrest warrants for the two male suspects and the victim's female acquaintance. In late July, the two male suspects, identified as Jose Luis **GOMEZ OCHOA** and Jordy Antonio **BAIRES-BONILLA**, were arrested. Attempts to locate the female acquaintance, identified as Fatima **CRUZ CRUZ**, have been unsuccessful. The U.S. Marshals Fugitive Task Force assisted in the apprehension of one of the suspects.

**Continuation from the investigative update on the previous page.*

Armed Robbery [Previously Released] - On April 1 at 1:29PM, officers responded to investigate a robbery that was reported to have occurred in the 7800 block of Brookview Ct. in Manassas (20109) earlier that morning at approximately 2:00AM. The investigation revealed the victim, a 17-year-old male juvenile, was meeting a female acquaintance in the above area when two men entered their vehicle. During the encounter, the victim was struck by both men and the female acquaintance before one of the men retrieved a firearm. The victim was physically struck with the firearm, rendering him temporarily unconscious. Later that morning, the victim woke inside the vehicle and went to an area hospital where police were contacted. A phone and purse were reported missing. **Preliminarily, the incident does not appear to be random.**

Incidents

Strangulation (Domestic Related) - On July 20 at 1:48AM, officers responded to a residence located in the 15500 block of Toddsbury Ln. in Manassas (20112) to investigate a domestic dispute. The investigation revealed the victim, a 44-year-old woman, and a family member, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused grabbed the victim's neck before leaving the residence. Minor injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as Dewayne Lawrence **JAMES**. Attempts to locate the accused have been unsuccessful.

Arrests

Assault with a Caustic Substance (Domestic Related) - On July 20 at 7:57PM, officers responded to the Longview Apartment complex located in the 13700 block of Lynn St. in Woodbridge (22191) to investigate a domestic dispute. The investigation revealed the victim, a 24-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused took the victim's phone preventing her from contacting the police before striking her. At one point during the assault, a male acquaintance of the accused, grabbed the victim's neck before the accused sprayed the victim with an eye irritant. Eventually, the parties separated, and the men left the apartment. Minor injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as Zaire Tucany **EZELL**, who was located and arrested without incident on July 23. The investigation continues as officers attempt to identify and locate the male acquaintance.

Sexual Assault Investigation - On April 5 at 2:51PM, detectives began an investigation into sexual assaults that were reported to have occurred in the Woodbridge area of Prince William County in March 2024. The investigation revealed the female victim, who was under the age of 18 at the time of the offenses, was sexually assaulted by an acquaintance, identified as the accused, on more than one occasion. One incident occurred in a vehicle at the Occoquan Commuter Lot located near Gordon Blvd. and Old Bridge Rd., while a separate incident occurred in a parking lot located in the 5100 block of Dale Blvd. The victim later reported the incidents to a family member who contacted the police. The victim and accused were both members of the Civil Air Patrol at the time of the offenses where the accused had a supervisory role over the victim. Following the investigation, detectives obtained arrest warrants for the accused, identified as Keith Richard **WILSON**, who turned himself in to police on July 22.

Brandishing of a Firearm – On July 23 at 7:56PM, officers responded to the boat ramp at the end of Forest Hill Rd. in Woodbridge (22192) to investigate a brandishing. The investigation revealed a group and another man, later identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused struck a member of the group, an 18-year-old man, before brandishing a firearm. While investigating the incident, officers determined the accused was intoxicated and detained him without incident. No shots were fired during the incident, and no injuries were reported. Following the investigation, the accused, identified as Kody Edward **PERRY**, was arrested.

The investigation revealed the victim, a 49-year-old man, observed a female acquaintance and a man, later identified as the accused, involved in a verbal altercation. When the victim attempted to intervene, the accused brandished a firearm before leaving the area. Officers located the accused nearby where he was detained without incident. The weapon was later determined to be an air soft gun. Following the investigation, the accused, identified as Nicolas Andre **PERINI**, was arrested.
