Updates

Murder Investigation *ARREST – On July 10, 2024, the suspect, identified as Tyus James **TERRELL**, who was sought in connection to the murder of a 26-year-old man stemming from an altercation between the two men that occurred in the 3700 block of Wharf Ln. in Triangle (22172) on November 14, 2023, was arrested. On the afternoon of July 10, 2024, the U.S. Marshals Service notified Prince William County police of the apprehension by members of their Fugitive Task Force which took place in the area of Dale Blvd and Neabsco Mills Rd in Woodbridge. Detectives had previously identified **TERRELL** as the suspect in the case the day after the fatal shooting in November 2023, and a reward was offered for his arrest and conviction.

Murder Investigation *REWARD INCREASED [Previously Released] – The Prince William County Police Department has increased the reward offered for information on the whereabouts of the suspect sought in connection to the shooting death of a 26-year-old man following an altercation that occurred in the 3700 block of Wharf Ln. in Triangle (22172) on November 14. During the investigation, the suspect involved in the shooting was identified as Tyus James **TERRELL**. Detectives obtained arrest warrants for the suspect and an initial reward amount was offered for information leading to his arrest and conviction. Further attempts and leads in locating the suspect have been unsuccessful. **The police department is now offering an increased reward of up to \$10,000 for information that leads to the arrest and conviction of this suspect.** The investigation continues.

Murder Investigation *REWARD [Previously Released] – The Prince William County Police Department is offering a reward for information on the whereabouts of the suspect sought in connection to the shooting death of a 26-year-old man that occurred in the 3700 block of Wharf Ln. in Triangle (22172) on November 14. During the investigation, the suspect involved in the shooting was identified as Tyus James **TERRELL**. Attempts and leads in locating the suspect have been unsuccessful. **The police department is offering a reward of up to \$5,000 for information that leads to the arrest and conviction of this suspect.** The investigation continues.

Murder Investigation *SUSPECT IDENTIFIED [Previously Released] – On November 15, detectives identified a suspect involved in the fatal shooting that was reported to have occurred in the 3700 block of Wharf Ln. in Triangle (22172) on November 14. While investigating the incident, detectives identified the suspect as Tyus James **TERRELL**, and obtained warrants for his arrest. While investigating the homicide, Prince William County detectives, with the assistance of the Spotsylvania County Sheriff's Office, executed multiple search warrants in Spotsylvania County in connection to the ongoing investigation. Attempts to locate the accused were unsuccessful. **Both parties were known to one another, and the incident was not random.** Detectives are continuing to actively investigate the incident to determine what led up to the shooting and are seeking to speak with anyone who has information regarding this incident or the whereabouts of the accused. More information will be released when available. The investigation continues.

Homicide Investigation [Previously Released] – On November 14 at 8:41PM, officers responded to the 3700 block of Wharf Ln. in Triangle (22172) to investigate a shooting. The investigation revealed gunshots were heard in the area which struck a 26-year-old man who was found lying on the ground by responding officers. Officers provided immediate first aid to the man who was transported to an area hospital where he later died from his injuries. While checking the area, officers located shell casings in the roadway on Wharf Ln. and a residence in the Linden Park Apartment complex that was struck by gunfire. No other injuries or property damage were reported. Arrests

Strangulation (Domestic Related) – On July 10 at 7:50PM, officers responded to a residence located in the 13700 block of Gilbert Rd. in Woodbridge (22193) to investigate a domestic dispute. The investigation revealed the victim, a 35-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused grabbed and struck the victim before the parties separated. Minor injuries were reported. While investigating the incident, officers were informed of a previous domestic dispute that was reported to have occurred on July 8. During the previous dispute, the accused grabbed the victim's neck and struck their 4-year-old daughter. Following the investigation, the accused, identified as Jose Olegario **LOPEZ**, was arrested later that evening.

Brandishing of a Firearm – On July 10 at 8:12PM, officers responded to Walmart located at 9401 Liberia Ave. in Manassas (20110) to investigate a brandishing. The investigation revealed the victim, a 43-year-old man, and an unknown man, later identified as the accused, were involved in a physical altercation in the parking lot before the parties separated. At one point, the accused brandished a firearm toward the victim before the accused and an acquaintance went back into the store. Officers located the accused inside the store and detained him without incident. No shots were fired during the encounter. Following the investigation, the accused, identified as Deon Dwight **HOLLAND**, was charged.
