Incidents

Shooting into a Residential Dwelling – On June 28 at 8:33PM, officers responded to the 4800 block of Kempair Dr. in Woodbridge (22193) to investigate a destruction of property. The investigation revealed two men fired multiple rounds before getting into a grey sedan and driving out of the area. A home and two unoccupied vehicles were struck by gunfire. No injuries or additional property damage were reported. Shell casings were located near the intersection of Kempair Dr. and Kim Ct. The suspects were described as black males, between 18-20 years old. One suspect was wearing a black shirt while the other wore a white shirt.

Assault & Battery on a Law Enforcement Officer [LEO] – On June 30 at 12:13PM, officers responded to Target located at 2460 Prince William Pkwy in Woodbridge (22192) to investigate a shoplifting. Store security detained a man and a woman for concealing merchandise. While investigating the incident, the female suspect attempted to run from officers before being detained without further incident. The male suspect then pushed himself into an officer before running out of the store. Officers and a police K-9 searched the area for the male suspect who was not located. Minor injuries were reported. Following the investigation, the female suspect was arrested. The investigation continues as officers attempt to identify and locate the male suspect.

Suspect Description:

A black male approximately 6'0"

Last seen wearing a red hat, a white tank top, black shorts, and black shoes with red laces

Commercial Burglary – On June 30 at 1:17PM, officers responded to investigate a burglary that was reported to have occurred at Pho Sapa located at 9983 Sowder Village Sq. in Manassas (20109) during the early morning of June 28. The investigation revealed two men entered the business through an unsecured rear door and took the tip jar. No additional property was reported missing.

Suspect Descriptions:

Two men, one wearing a grey hooded sweatshirt, black pants, and carrying a black backpack while the other man had a medium build and was last seen wearing a black short sleeve shirt, black pants, and black sneakers with red highlights

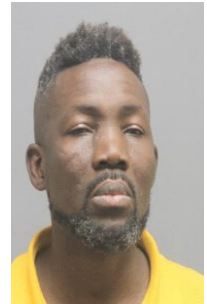

Attempted Commercial Burglaries – On June 30 at 11:32AM, officers responded to investigate multiple attempted burglaries that were reported to have occurred at the Maplewood Shopping Center located in the 8200 block of Shoppers Sq. in Manassas (20111) earlier that morning at approximately 3:27AM. Surveillance footage revealed a man tampered with the door locks on multiple businesses in the shopping center including the MegaMart, Metro by T-Mobile, and Teppanyaki Grill & Supreme Buffet. Officers determined the suspect vandalized the locks on all three business doors. No entry was made into the businesses and no property was reported missing. The suspect was described as a heavy-set male last seen wearing a face covering, a blue shirt, and shorts.

Arrests

Rape – On June 28 at 1:00PM, officers responded to investigate a sexual assault that was reported to have occurred at a residence located in the 6100 block of Trident Ln. in Woodbridge (22193) on the evening of June 27. The investigation revealed the victim, a 30-year-old woman, was sexually assaulted by a man she recently met, later identified as the accused, while the two were at his residence in the above area. The victim was able to leave the home the following morning and contacted the police. During the investigation, detectives identified the accused as Abdul **KANU**, who was later arrested.

Armed Robbery – On June 28 at 8:56PM, officers responded to the 2700 block of Corbin Ct. in Woodbridge (22191) to investigate a robbery. The investigation revealed the victim, an 8-year-old boy, observed an acquaintance, identified as the accused, take his bicycle from in front of a residence in the above area. When the victim confronted the accused, he brandished a firearm before riding off on the bicycle. No shots were fired and no injuries were reported. The victim told a family member who contacted the police. While investigating the incident, another juvenile was observed riding the bicycle which was subsequently recovered. Following the investigation, the accused, identified as a **13-year-old male juvenile** was arrested.

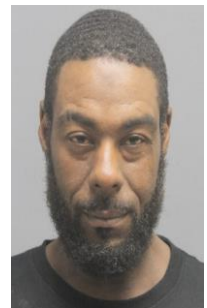

Strong-Arm Robbery – On June 30 at 10:54PM, officers responded to the 9600 block of Lomond Dr. in Manassas (20109) to investigate a robbery. The investigation revealed the victim, a 30-year-old man, was walking in the above area when he was approached by a man he had previously seen in the area, later identified as the accused. During the encounter, the accused took the victim's wallet and pushed the victim before running away. While investigating the incident, officers located the accused a short distance away where he was detained without incident. No injuries were reported. Following the investigation, the accused, identified as Terry Brian **WATSON**, was arrested.

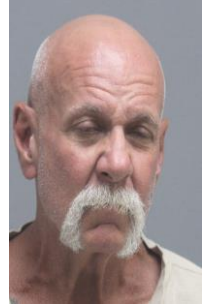

Abduction – On June 28 at 2:42AM, officers responded to investigate an abduction which was reported to have occurred at the Sleep Inn located at 14080 Shoppers Best Way in Woodbridge (22192) on the evening of June 27. The investigation revealed the victim, a 30-year-old woman, was taken against her will from Pennsylvania and brought to the above hotel by an acquaintance, identified as the accused. At one point, an acquaintance of the victim notified the police of the victim's location in Virginia. Responding officers located both parties at the hotel room where the accused was detained without incident. The accused was also found in possession of the victim's personal belongings. No injuries were reported. Following the investigation, the accused, identified as Robert **BUCHANAN**, was arrested.
