### Updates

**Malicious Wounding \*ADDITIONAL ARREST** – On July 15, a fifth suspect, identified as Tayvion Omari **THORNTON**, who was sought in connection to the shooting that occurred at Manassas Mall located at 8300 Sudley Rd in Manassas (20109) on July 9, was arrested. At this time, investigators believe the main suspects involved in the shooting have been identified and arrested. Additional individuals are being sought as potential witnesses to the incident. **Malicious Wounding \*ADDITIONAL ARREST | WANTED SUSPECT [Previously Released]** – Over the course of the investigation, detectives have identified and charged two additional men in connection to the shooting that occurred at Manassas Mall located at 8300 Sudley Rd in Manassas (20109), on July 9. One of those men, identified as Eric Ronaldo **BENITEZ**, has since been taken into custody. The second suspect, identified as Tayvion Omari **THORNTON**, is currently being sought and attempts to locate this individual have been unsuccessful. At this time, investigators believe the main suspects involved in the shooting have been identified and charged. **Malicious Wounding \*ARRESTS [Previously Released]** – On July 9, Prince William County detectives charged three men in connection to the shooting that occurred at Manassas Mall located at 8300 Sudley Rd in Manassas (20109) earlier that day. Two of the men arrested were suspects initially detained by officers following a traffic stop shortly after the shooting had occurred. The third suspect charged was the 23-year-old man who was one of two men injured during the altercation and determined to be in one of the groups involved in the shooting incident. The third suspect remains hospitalized in police custody. Investigators are still seeking the identities of several other suspects. **Anyone who witnessed the incident or has information to identify the pictured suspects or can otherwise aid in the investigation is asked to contact police at 703-792-6500.** The investigation continues.

**Shooting Investigation \*SUSPECTS SOUGHT [Previously Released]** – Prince William County detectives are seeking the identities of several parties in connection to the shooting that occurred at Manassas Mall located at 8300 Sudley Rd in Manassas (20109) on July 9. The investigation revealed two groups met at the mall near the food court where a physical altercation ensued. During the encounter, multiple firearms were brandished by both groups before the altercation exited into the parking lot. Once in the parking lot, outside the mall, shots were exchanged between both groups before the parties dispersed. No shots were fired inside the mall. One of the injured parties from the group, identified as a 23-year-old man, was driven by other associates to an area hospital where police were notified. An uninvolved bystander, identified as a 51-year-old man, was located at the scene and treated at an area hospital for a wound to the upper body (correction from *the lower body* in an earlier release). Both men are expected to survive. A search of the area by a police K-9, resulted in evidence including multiple firearms being recovered. Additionally, two men were detained nearby following a traffic stop shortly after the shooting. Charges are pending. Multiple resources from Manassas City police, Manassas Park police, the Prince William County Sheriff's Office, Fairfax County police helicopter, and the Prince William County Department of Fire & Rescue responded to the scene to offer assistance. Detectives are actively seeking the identities of the pictured suspects in connection to this incident. **Anyone who witnessed the incident or has information to identify the pictured suspects or can otherwise aid in the investigation is asked to contact police at 703-792-6500.** The investigation continues.

**Shooting Investigation [Previously Released]** – On July 9 at 2:08PM, officers responded to Manassas Mall located at 8300 Sudley Rd in Manassas (20109) to investigate a shooting-in-progress. Arriving officers conducted a precautionary search of the building resulting in no active scene being identified. Preliminary indications are an altercation occurred outside the mall in the parking lot between two groups. At one point during the encounter, shots were fired, and the parties dispersed. Uninvolved parties and possible witnesses ran into the mall alerting others to the incident in the parking lot, sparking initial panic. Two injured parties have been identified, one was taken to an area hospital with a gunshot wound to the lower body where police were notified, and the other was located on the scene with a minor wound to the lower body believed to have been caused by a ricochet. No additional information is known about these individuals or their possible involvement, if any, in the incident. Both parties are expected to survive. A vehicle has been stopped near the incident and additional parties have been detained. Their involvement in the incident has not been confirmed at this time. Police remain on the scene. **The incident is contained and is not believed to be random.** Investigators are asking anyone who may have witnessed the incident or has information to aid in the investigation to contact police at 703-792-6500. General access to the mall may be restricted at this time as the investigation continues.

**Strong-Arm Robbery \*ARREST** – On July 15, officers concluded an investigation into a robbery that was reported to have occurred in the 7300 block of Sudley Rd. in Manassas (20109) on July 5. While investigating the incident, officers identified and obtained arrest warrants for the suspect, identified as the accused. On July 15, the accused, identified as Brianna Grace **INGRAM**, was arrested without incident.

**Strong-Arm Robbery [Previously Released]** – On July 5 at 2:32PM, officers responded to the 7300 block of Sudley Rd. in Manassas (20109) to investigate a robbery. The investigation revealed the victim, a 34-year-old man, was getting out of his vehicle when an unknown woman attempted to take his wallet. When the victim attempted to pull away, the suspect bit the victim's hand and took his wallet before running away. Officers and a police K-9 searched the area for the suspect who was not located. The victim reported minor injuries.

## Incidents

**Aggravated Assault** - On July 14 at 2:23AM, officers responded to Afterlife 360 located at 8090 Sudley Rd. in Manassas (20109) to investigate an assault. The investigation revealed the victim, a 34-year-old man, was speaking to an unknown woman when he became involved in a physical altercation with a group of individuals who struck him with an unknown object. The altercation continued into the parking lot where acquaintances of the victim intervened. One of the acquaintances, a 23-year-old man, was physically struck in the face with a firearm before the parties separated. The victim and acquaintance were treated at an area hospital for non-life threatening injuries where police were contacted. No shots were fired, and no additional injuries were reported.

***Suspect Description:***

A Hispanic male, with a medium build, and long wavy hair

Last seen wearing a light-colored shirt and long shorts while carrying a firearm

**Carjacking** - On July 16 at 1:34AM, officers responded to Prince William Plaza located at 14428 Richmond Hwy. in Woodbridge (22191) to investigate a robbery. The investigation revealed the victim, a 53-year-old man, was inside his vehicle when he was approached by an unknown woman and two unknown men. One of the men asked the victim for money while the other man got into the passenger side of the victim's vehicle where he then threatened the victim. When the victim got out of the vehicle, he was assaulted by the woman before running out of the area. The suspects took the victim's vehicle and left the area. No injuries were reported. The suspects were only described as two black males, and one black female.

**Commercial Burglary** - On July 16 at 2:48AM, officers responded to the Public Storage located at 1365 Old Bridge Rd. in Woodbridge (22192) to investigate an alarm activation. The investigation revealed two unknown individuals cut through the secured exterior fence and forced entry into the building. Once inside the building, locks on multiple storage units were cut. Officers and police K-9 searched the area for the suspects who were not located. No items have been reported missing at this time. The suspects were described as wearing all dark-colored clothing and masks.

**Residential Burglary** – On July 14 at 3:12PM, officers responded to a residence located in the 8000 block of Community Dr. in Manassas (20109) to investigate a burglary. The investigation revealed entry was made into the home through a shattered front window sometime during the overnight hours. No property was reported missing.

**Attempted Residential Burglary** – On July 13 at 4:56PM, officers responded to The Landings at Markhams Grant Apartments located in the 15700 block of Tassleford Ln. in Woodbridge (22191) to investigate an attempted burglary. The investigation revealed sometime between July 1 and July 13, multiple windows to the apartment were damaged. No entry was made into the residence and no property was reported missing.

## Arrests

**Attempted Malicious Wounding** – On July 15 at 10:45AM, officers responded to a residence located in the 6200 block of Sierra Ct. in Manassas (20111) to investigate an attempted stabbing. The investigation revealed the victim, a 51-year-old man, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused attempted to stab the victim with a knife before the victim left the room and contacted police. The accused remained inside the residence and refused to follow the officer's commands. Minor injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as Maurice **HOWELL**, who surrendered to officers later that afternoon.
