### Incidents

**Reckless Handling of a Firearm | Road Rage Related** – On July 30 at 1:03AM, officers responded to the area of Prince William Pkwy near Smoketown Rd. in Woodbridge (22193) to investigate a shots fired call. The investigation revealed the victim, a 29-year-old man, was driving on Prince William Pkwy. when he was involved in a road rage incident with the driver of a Dodge Charger. While the drivers were stopped near the above intersection, a verbal altercation ensued. During the encounter, gunshots were fired, striking the victim's vehicle. Both vehicles left the area, and the victim contacted the police. No injuries or additional property damage reported.

**Attempted Strong-Arm Robbery** – On July 28 at 6:25PM, officers responded to the Sunoco located at 3220 Old Bridge Rd. in Woodbridge (22192) to investigate an attempted robbery. The investigation revealed the victim, a 23-year-old man, was at the gas pumps when he was approached by two unknown men. During the encounter, one of the men struck the victim with a windshield washer squeegee while the other man went into the victim's vehicle. Both men eventually left the area. No injuries were reported, and no property was reported missing.

**Residential Burglary** – On July 28 at 8:03AM, officers responded to investigate a burglary that was reported to have occurred at the Westgate Apartments located in the 8000 block of Ashland Ave. in Manassas (20109) during the overnight hours. The investigation revealed sometime between 10:00PM on July 27 and 7:05AM on July 28, forced entry was made into the apartment through the front door which was found unsecured. No property was reported missing. Officers also determined that the driver's door of the victim's vehicle was smashed and a purse along with an undisclosed amount of money was missing from the vehicle.

**Attempted Residential Burglary** – On July 30 at 3:30AM, officers responded to the Coverstone 4 Apartments located in the 7600 block of Cass Pl. in Manassas (20109) to investigate an attempted burglary. The investigation revealed a resident of the apartment woke to a loud noise and found the kitchen window smashed. An individual was also seen outside the apartment quickly leaving the area. A police K-9 searched the area for the suspect who was not located. No entry was made into the apartment and no property was reported missing.

## Arrests

**Contributing to the Delinquency of a Minor** – On July 29 at 8:51AM, officers responded to the area of Signal Hill Rd. near Liberia Ave. in Manassas (20111) to investigate a found child. The investigation revealed the victim, a 3-year-old girl, was left unattended for an extended period by her grandmother, identified as the accused. A Good Samaritan located the child outside unsupervised and contacted the police. While investigating the incident, the accused returned to the residence. The child did not appear to be injured and was released to the custody of known parties. Following the investigation, the accused, identified as Raquel **MORROBEL HERNANDEZ**, was charged.
