### Updates

**Attempted Malicious Wounding \*ARREST** – On July 25, detectives concluded the investigation into the shots fired call that was reported to have occurred in the area of Smoketown Rd. and Purdham Dr. in Woodbridge (22192) on July 21. Further investigation revealed the victims and an acquaintance, identified as the accused, were involved in a verbal altercation while at a residence in the 12700 block of Purdham Dr. earlier that morning. During the encounter, the accused brandished a firearm before the parties separated. When the victims left the residence later that morning, the accused fired multiple rounds, striking the victim's vehicle several times. Following the investigation, detectives obtained arrest warrants for the accused, identified as Maryam **RAZA**, who was taken into custody by Fairfax County police on July 25.

**Shooting Investigation [Previously Released]** – On July 21 at 5:35AM, officers responded to the area of Smoketown Rd. and Purdham Dr. in Woodbridge (22192) to investigate a shots fired call. The investigation revealed the victims, a 19-year-old man and woman, were driving in the above area when an occupant in a black Honda Civic fired at their vehicle. When the victim attempted to drive away, the Civic followed and fired additional rounds as the vehicles traveled along Old Bridge Rd. near Smoketown Rd. Eventually, the victims stopped at a local business while the suspect vehicle continued driving away. The victims reported minor injuries from shattered glass. No additional injuries or property damage were reported.

## Incidents

**Commercial Burglary** – On July 24 at 11:46AM, officers responded to The K Pot restaurant located at 8121 Sudley Rd. in Manassas (20109) to investigate a burglary. The investigation revealed sometime between 5:00PM on July 23 and 7:30AM on July 24 entry was forced into the business through a rear door which was found damaged. Power tools and supplies were reported missing.

**Residential Burglary** – On July 24 at 6:55PM, officers responded to the Riverside Station Apartments located in the 14000 block of Big Crest Ln. in Woodbridge (22191) to investigate a burglary. The investigation revealed entry was made into the apartment sometime between July 18 and July 24. There were no signs of forced entry and jewelry was reported missing.

**Suffocation (Domestic Related)** – On July 23 at 4:37AM, officers responded to a residence located in the 3500 block of Nexus Ct. in Woodbridge (22192) to investigate a domestic dispute. The investigation revealed the victim, a 31-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused struck the victim before attempting to suffocate her. Eventually the parties separated, and the police were contacted. Minor injuries were reported. Following the investigation, the accused, identified as Maikel **BARRERA AGUILAR**, was arrested.
