Updates

Sexual Assault Investigation *ARREST – On June 25, 2024, the suspect, identified as Nelson **ROMERO-QUIJADA**, who was wanted in connection to a sexual assault that was reported to have occurred at a residence located in the 7900 block of Community Dr in Manassas (20109) in 2018, was taken into custody in El Salvador in a coordinated effort with the Department of Justice. In September 2018, the accused was identified by investigators and publicly named as the suspect involved in the assault of an 8-year-old boy that occurred between October 2014 and July 2016. Police have been seeking the whereabouts of the accused since that time and had received information that he fled the country. On July 11, 2024, the accused was extradited back to Prince William County.

Sexual Assault Investigation [Previously Released] – On August 13, 2018, detectives from the Special Victim's Unit began to investigate a sexual assault that occurred at a residence located in the 7900 block of Community Dr in Manassas (20109). The investigation revealed that the accused, an acquaintance, sexually assaulted the victim, an 8-year-old boy at the time, between October 2014 and July 2016. The victim recently disclosed the assaults to a family member who contacted police. Following the investigation, detectives obtained warrants for the arrest of the accused, identified as Nelson **ROMERO-QUIJADA**. Attempts to locate the accused have been unsuccessful.

Incidents

Malicious Wounding – On July 16 at 6:47AM, officers responded to investigate an assault that was reported to have occurred at the Elevations One Apartments located in the 1900 block of Stevens Rd. in Woodbridge (22192) at approximately 1:30AM. The investigation revealed the victim, a 37-year-old man, was in the parking lot when he was approached by an unknown man. During the encounter, the suspect brandished a machete-style knife and cut the victim multiple times before the victim fell to the ground. At that point, the suspect grabbed the victim's neck before the parties eventually separated. The victim later went to an area hospital for treatment of non-life threatening injuries where police were contacted. The victim refused to cooperate further with officers during the investigation.

Strangulation (Domestic Related) – On July 16 at 11:22PM, officers responded to the Orchard Mills Apartments located in the 3200 block of Berlin Ct. in Woodbridge (22193) to investigate a domestic dispute. The investigation revealed the victim, a 34-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused wrapped his arm around the victim's neck before the parties separated. The accused left the residence prior to police arriving at the apartment. Minor injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as Steve Pascal Henri **CALIXTE**. Attempts to locate the accused have been unsuccessful.

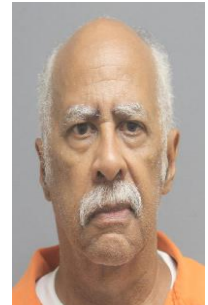

Arrests

Aggravated Sexual Battery – On June 22, 2024, officers began an investigation into a sexual assault that was reported to have occurred at the Chinn Park Recreation Center located at 13025 Chinn Park Dr. in Woodbridge (22192) between April and May 2022. The investigation revealed the victim, who was under the age of 13 at the time of the offenses, was sexually assaulted on more than one occasion by a swim instructor, identified as the accused, during swim lessons. Following the investigation, the accused, identified as Daniel **SMITH**, was arrested.



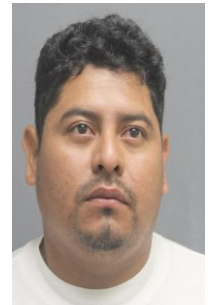

Attempted Malicious Wounding (Domestic Related) – On July 17 at 12:38AM, officers responded to a residence located in the 1800 block of Wigglesworth Way in Woodbridge (22191) to investigate a domestic dispute. The investigation revealed the victim, a 24-year-old woman, and a family member, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused brandished a machete-style knife towards the victim before leaving the area. Officers detained the accused nearby after a brief struggle where he was also determined to be intoxicated. No injuries were reported. Following the investigation, the accused, identified as Jaime **GARCIA NOLASCO**, was arrested.

Armed Robbery – On July 16 at 3:12PM, officers responded to the Signal Hill Apartments located in the 15200 block of Colony Pl. in Woodbridge (22191) to investigate a robbery. The investigation revealed the victim, a 16-year-old male juvenile, arranged to sell items to an unknown individual, later identified as the accused. During the exchange, the accused brandished a firearm before he and an acquaintance took the items from the victim and left the area. Responding officers located the accused and detained him without incident. No shots were fired, and no injuries were reported. Following the investigation, the accused, identified as a **15-year-old male juvenile**, was arrested. The investigation continues as officers attempt to identify and locate the second suspect involved in the incident.
