### Incidents

**Homicide Investigation** – On July 18 at 8:23PM, officers responded to the area of Pineview Rd and Cregger Ln in Manassas (20111) to investigate a shooting. Officers arrived on the scene and located an 18-year-old woman in a nearby wooded area suffering from gunshot wounds to the upper body. The woman was pronounced dead on the scene. No other injuries or property damage were reported, and no suspects have been located at this time. Detectives are actively investigating the incident to determine what led up to the shooting and are seeking to speak with anyone who can aid in the investigation. **Preliminarily, the incident does not appear to be random.** More information will be released when available. The investigation continues.

**Strong-Arm Robbery** – On July 19 at 2:34AM, officers responded to the 14500 block of Gideon Dr. in Woodbridge (22192) to investigate a robbery. The initial investigation revealed the victim, a 45-year-old man, was behind a local business when he was approached by three unknown men. During the encounter, a struggle ensued when the suspects took headphones, a phone, and tobacco products from the victim's backpack. The suspects drove away in a grey Nissan Maxima. The victim eventually reported the incident to police. Minor injuries were reported. There were several inconsistencies in the victim's account of the events. The suspects were only described as black males, one of whom had tattoos on his hand while another reportedly had dreadlocks.
