- **Staff training** that ensures compliance requirements are understood before the award arrives.
- **Community engagement** to build strong project designs, inclusive assessments, and generate local support

## Going Beyond the Application

Ok, so you've won a grant, congratulations! Now what do you do? Grants come with responsibilities that can be overwhelming if an organization isn't prepared. Post-award grant management is where projects succeed or stumble.

This stage includes tracking expenses, ensuring all purchases meet funder requirements, reporting progress, and preparing for audits. For public agencies, this also means aligning grant-funded purchases with broader procurement policies and local regulations.

To avoid the panic that follows from the joy of being awarded funding, do you have a plan in place for invoicing, subrecipient monitoring, and compliance tracking? As an example, the Justice40 Accelerator collaboration enrolled participants who had limited grant experience. They walked away not just with stronger proposals but with systems, evaluation tools, and funder connections they'll use for years. For groups historically left out of funding streams, accelerators and other capacity-building training can be game-changing.
