***Which of your personal and professional experiences do you believe will most contribute to the work of the GCA Board of Directors?***

During my career of over thirty-five years, I have been employed in small organizations where I dealt with the full range of operational issues, and in large organizations in which I supervised sizable staffs. During my career in the public health and occupational/environmental health and safety fields, I served as manager, director, or Vice President at companies ranging from the world's largest conglomerate to a small startup. I also served as Vice-President and as staff for an industry trade association, worked for a state public health department, and at the end of my career, ran my own consulting business. Through my trade association and consulting work, I personally had bottom line responsibility for the project and financial management for more than \$60 million of scientific research. I believe this experience has taught me how to analyze complex technical or financial issues, how to communicate clearly about them, and how to effectively manage projects.

I have a Master's Degree in biochemistry from The Ohio State University, an MBA from Columbia University/Fairleigh Dickinson University, and a Ph.D. in Occupational/Environmental Health from the University of Michigan. I served as a Captain in the U.S. Army Special Forces in Vietnam as a medical services officer in the Army Medical Corps.

Before moving to Glenmore full-time, I served for five years as President of the Chesterbrook Farm Homeowners Association in McLean, Virginia. This experience familiarized me with the range of issues homeowners routinely encounter, as well as introduced me to the kinds of local and state organizations/authorities in Virginia who are often in a position to address such issues.

I am currently enjoying retirement and partaking of all that Glenmore has to offer, including tennis, walking our beautiful streets and trails with our golden doodle, taking the grandkids to riding lessons and the pool, and delighting in the company of my fellow residents.
