Second Look Day Procedures

- 1. Three (3) days prior to their scheduled day**, students bring their completed forms to the home school counseling office.
- 2. Home school counseling office scans DACC all completed forms** (including medical information on the back) **and retains a copy** of the completed form.
 - We must have emergency medical information **BEFORE** visit day.
- 3. Two (2) days prior to scheduled visit**, home school guidance office reports students attending by contacting the following:
