## Laureus USA Funding Opportunity in Illinois

### General Overview

#### ***Funding Opportunity***

Laureus USA is pleased to announce a \$4,000,000 funding opportunity for sports-based youth development organizations operating in the state of Illinois. This program is funded by the American Recue Plan Act through Illinois Criminal Justice Information Authority's (ICJIA).

#### ***Eligibility***

Laureus USA funds non-profit sport-based youth development organizations that intentionally address a particular and relevant social issue facing youth, while increasing physical activity and enhancing social-emotional development. This grant opportunity will focus on organizations creating impact in the following two ways:

1. Organizations working on violence prevention and intervention services/ focused on creating access to safe spaces, building protective factors for youth through positive relationships, and developing transferrable life skills/competencies
2. Organizations with expertise in providing training and technical assistance (TA) on sports-based youth development program quality, healing-centered coaching/programming, and/or restorative justice practices and implementation

Organizations can only submit one application for this funding opportunity and must choose between the two eligibility pathways.

Organizations must meet the following criteria to be considered for funding:

- Provide direct-service sports programming for youth or provide training or TA to organizations as described above
- Have an active 501(c)3 status and EIN #
- Operate in, serving youth from, or planning to serve youth from within the state of Illinois
- [Have a Data Universal Numbering System \(DUNS\) or Unique Entity ID \(UEI\) number](#)
- [Be registered with the System for Award Management \(SAM\)](#)

Organizations that meet the following criteria will be prioritized for funding:

- Operate in an [R3 Zone](#). R3 Zones were identified via an analysis of community-level data on gun injury, child poverty, unemployment, and state prison commitments and returns. Organizations from these areas will be prioritized for meeting the intended impact of this program to expand equity of access in youth sports and impact levels of youth violence.
- Intentionally prioritize diversity, equity, and inclusion in recruiting, hiring, and engaging program staff/ participants
- Demonstrate a sustainable organizational structure

# REQUEST FOR PROPOSALS

- Demonstrate commitment to leadership and resource development in the field of sport for development

We do not fund:

- Organizations that do not emphasize positive youth development through their programming
- Other foundations or intermediaries that do not provide direct sports-based youth development programming or training
- Pay to play organizations such as for-profit youth sports leagues
- Projects focused on training for elite-level athletic achievement
- Government Agencies (Including Parks, Schools and/or scholastic sports leagues)

## Grant Amounts

### Direct Service Organizations

Direct Service Organizations can apply for \$50,000, \$100,000, or \$200,000 to support specific projects or programs that their organization delivers. We expect the vast majority of these grants to be made at the \$100,000 level.

These grants are distributed through monthly reimbursement (rather than a single grant payment).  
Reimbursement should be expected 2-4 weeks after expenses are submitted. The entire grant budget

must be spent between October 1<sup>st</sup>, 2022 and June 30<sup>th</sup>, 2023. Any funds that are not spent will be reallocated or returned to ICJIA.

While organizational budget is only one indicator of readiness, our general recommendation is for organizations to follow the guidance below.

- Organizational Budget <\$200,000 – Apply for \$50,000 funding
- Organizational Budget \$200,000 - \$1,500,000 – Apply for \$100,000 funding
- Organizational Budget >\$1,500,000 -- Apply for \$100,000 or \$200,000 funding (understanding that \$200,000 will be much more competitive due to fewer grants)

## Training Organizations

Training organizations can apply for \$50,000 or \$100,000 to support specific training projects or programs.

These grants are distributed through monthly reimbursement (rather than a single grant payment). Reimbursement should be expected 2-4 weeks after expenses are submitted. The entire grant budget must be spent between October 1<sup>st</sup>, 2022 and June 30<sup>th</sup>, 2023. Any funds that are not spent will be reallocated or returned to ICJIA.

*\*Note that there is no match requirement for either type of grant award.*

## **Application**

We will begin accepting applications on **Friday, August 19th at 8am** and will accept applications until **Monday, September 19<sup>th</sup> at 11:59pm**. Late submissions or submissions made outside of the provided link will not be accepted under any circumstance.

Successful applicants will:

- Highlight their work in violence prevention and intervention
- Demonstrate basic standards in the areas of child protection, governance, monitoring and evaluation, partnership, and financial stewardship
- Demonstrate a commitment to diversity, equity, and inclusion across internal practices (leadership, staffing, and governance) as well as in programming and community engagement
- Commit to implementing the [Hello Insight](#) check-in tool once during the grant year (or supply description of how outcomes will be measured using a different tool)

In accordance with ICJIA's policies and procedures, organizations will be selected purely based on their application and rubric scores.

## ***Questions, Debrief, and Appeal Process***

Debrief – Applicants who do not receive funding may request a debriefing for feedback to improve future applications. Debriefings include written advice on the strengths and weaknesses of applications using the evaluation and review criteria. Requests for debriefings must be made via email to Ben Schornack at [ben.schornack@laureus.com](mailto:ben.schornack@laureus.com) and submitted within seven calendar days after notice of declination. The written debriefing requests shall include:

- The name and address of the requesting party
- Identification of grant program
- Reasons for the debrief request

Appeal – Unsuccessful applicants may request a formal appeal of the evaluation process. Evaluation scores and funding decisions may not be contested and will not be considered – this is only to appeal the process itself. The appeal must be submitted via email to Ben Schornack at [ben.schornack@laureus.com](mailto:ben.schornack@laureus.com) within 14 days after notice of declination. The appeal must include the following:

- Statement indicating request for formal appeal
- Name and address of appealing party
- Identification of the grant program
- Statement for reason of appeal

Once the appeal is received, Laureus will acknowledge receipt within 14 days and will respond to the appeal, in writing, within 60 days by including:

- Review of the appeal
- Appeal determination
- Rationale for the determination
- Standard description of the appeal review process/criteria
