

# Ride and Drive

## MHAO Trail/Riding/Driving Program

### **Program Rules:**

1. Open to all ages of riders/drivers and to all styles of riding or driving.
2. Enrollment year will begin and end on October 15<sup>th</sup>.
3. Must be an MHAO member.
4. Only hours on a Morgan horse will count.
5. Hours must be logged on the MHAO Log Sheet.
6. Horse's name and registration number must be included on the log sheet.
7. More than one horse may be used to accrue hours.
8. Eligible hours are any hours spent riding or driving either for recreation, trail riding, practice or to exercise your horse; or for hours in the saddle or driving at a non-Morgan competition or event. This includes 4H, OHSET, clinics, non-Morgan shows, etc. Time in the saddle or driving at a Morgan show count except for the time in front of a judge. See the enrollment form for more information.
9. The program is continuous and members can accrue hours over multiple enrollment years as long as MHAO membership is maintained.

**Cost:** Enrollment is a one time fee of \$15 as long as MHAO membership is maintained. Must re-enroll (including another fee) if MHAO membership is dropped.

**Awards:** Awards will be presented for 25, 50, 150, 1,000 and 2,000 hours at the MHAO Fall Banquet. Additional Awards will be determined by committee

## Ride & Drive Program New Enrollment

### Requirements:

1. Participants and Owner must be current MHAO Members.
2. Morgans must be permanently registered with the AMHA. Non-Morgan horses are not part of this program.
3. Please complete the enrollment form and submit it to MHAO prior to the first log form being submitted. Include a \$15 check for initial enrollment and send it to Karen Breckenridge, MHAO Treasurer.

### Reporting Credits:

1. Credits are earned by either logging time spent riding or driving in a competitive or non-competitive setting or by submitting points earned at any open to all breed events (4-H, local horse clubs, or recognized associations).
2. Participants may not report recreational and a horse event at the same time for credits and points.
3. Credits are awarded –Recreational time (trail riding) 1 Hour=1 point and 1 credit. Equine events 1 hour= 2 points and 2 credits.
4. Double Hours are awarded for time spent riding/driving in a national or state park, grassland area or historic areas as recognized by the U.S. or Canadian National Parks Service.
5. Credits must be reported on MHAO Ride & Drive Program Forms.
